#### What is ACCA County Days?

Held annually during the Ala. Legislative Session, ACCA County Days is the time for county commissioners and staff to come to Montgomery to meet face-to-face with legislators and advocate for their county and for county government as a whole. Each county is assigned a date, and participation in your County Day will be critical to our success during the 2018 Regular Session. We need you, your fellow commissioners and your fellow staff -- the people who constitute county government -- at the State House speaking on behalf of county government.

#### How can I prepare for my ACCA County Day?

Schedule a meeting with your legislators for your County Day. Set up those meetings today, tomorrow, anytime in advance of your County Day.

#### How do I share my ACCA County Day efforts with others?

While you're in Montgomery for your County Day, you can film a brief video about your County Day efforts at Studio 67, located next door to the ACCA headquarters. The ACCA staff will film and finalize your video and pass it along to you to share on your social media platforms and through other communications outlets.

Additionally, while in Montgomery, you can sit down with the ACCA staff to learn the ins and outs of Twitter -- how to create an account, how to fill in your profile, how to tweet, how to "hashtag," how to follow your legislators, etc. Most importantly, you can learn how to compete in (and help your county win) the ALCountiesTweet Competition.
