**SCOPE:** The purpose of this position is to operate heavy machinery in support of road construction, maintenance, and repair projects.

**REQUIRED HOURS OF AVAILABILITY:** Monday-Thursday; 6:00am – 4:30pm

## **EXAMPLE OF DUTIES PERFORMED:**

- Operates complex motorized equipment, including bulldozers, two-yard loaders, front end loaders, motor
  graders, low-boys, pavers, planers, tractor and trailer combinations, and other equipment; clears land for new
  streets; covers debris at dump sites; loads dirt and stumps onto dump truck; levels roads, and various other
  duties.
- Meets with Highway Supervisor to plan daily work assignments; inspects vehicles and equipment before use; loads tools and supplies; checks equipment for damage or other problems at end of day.
- Assists in the repair and maintenance of vehicles and equipment.
- Maintains and constructs drainage and sewer systems; replaces and packs dirt; assists with cleaning storm sewers; removes trash and debris from under storm box lids and out of gutters, inlets, and ditches; assists in the construction of concrete block/brick retaining walls; lifts, moves and lowers pipes; builds structures into the ground; oversees the replacement of landscaping.
- Maintains and repairs streets and related appurtenances; builds spillways; shores up existing structures; builds new streets and drive entrances; patches potholes; delivers asphalt to work sites; removes damaged asphalt; shovels, packs, and prepares new asphalt for rolling operation; cleans up patch site after completion.
- Performs pre-start-up inspections; maintains an awareness of all activity around assigned equipment and practices defensive driving when in pedestrian and vehicle traffic.
