**SUBJECT:** Revenue Code – Sex Offender Filing Fees

Act 2011-640, Acts of Alabama, provides for a filing fee in the amount of two hundred dollars (\$200) to be paid by a sex offender who petitions the court for relief beginning July 1, 2011. The Act states that \$50 of the filing fee collected will be paid to the law enforcement agency providing community notification. In some instances, the county sheriff's department will be the law enforcement agency providing community notification. In those instances, the following information will be needed.

**SUBJECT:** Revenue Code – Sex Offender Fines

Act 2011-640, Acts of Alabama, provides for a fine in the amount of two hundred fifty dollars (\$250) to be paid by a sex offender who is convicted of any offense specified in the Act beginning July 1, 2011. The Act states that \$50 of the fine collected will be paid to the local law enforcement agency providing notification. In some instances, the county sheriff's department will be the law enforcement agency providing notification. In those instances, the following information will be needed.

**SUBJECT:** Revenue Code – Sex Offender Registration Fees

Act 2011-640, Acts of Alabama, provides for an adult sex offender to pay a quarterly registration fee in the amount of ten dollars (\$10) to each registering agency where the offender resides beginning July 1, 2011. The Act states that the fees collected are to be appropriated to the registering agency to defray the costs of sex offender registration, verification, and notification. The county sheriff's department will be functioning as the registering agency in most situations.

**Allowable Uses of Revenues**

The revenues may be used only for expenses related to the costs of sex offender registration, verification, and notification.
