2 ENROLLED, An Act,

3 Relating to E-911 services, to amend Sections
4 11-98-1, 11-98-2, 11-98-4, 11-98-5, 11-98-6, 11-98-7, and
5 11-98-9, Code of Alabama 1975; to add Sections 11-98-4.1,
6 11-98-5.2, 11-98-5.3, 11-98-13, 11-98-13.1, 11-98-14, and
7 11-98-15 to the Code of Alabama 1975, to create a single,
8 statewide emergency service charge applicable to all voice
9 services provided within the state; to create a statewide 911
10 Board, which shall replace and supersede the existing
11 Commercial Mobile Radio Service (CMRS) Board and which would
12 be responsible for establishing and collecting an emergency
13 telephone service charge; to distribute the funds collected
14 from the service charge to communications districts and CMRS
15 providers; to establish a Permanent Oversight Commission and
16 to provide for the membership and duties of the commission; to
17 provide for the Department of Examiners of Public Accounts to
18 provide audit and other services and be reimbursed therefor;
19 and to repeal Sections 11-98-5.1, 11-98-7.1, and 11-98-8, Code
20 of Alabama 1975.

21 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

22 Section 1. Sections 11-98-1, 11-98-2, 11-98-4,
23 11-98-5, 11-98-6, 11-98-7, and 11-98-9, Code of Alabama 1975,
24 are amended to read as follows:

25 "§11-98-1.

1 "(a) As used in this chapter, the following words
2 and terms have the following meanings, unless the context
3 clearly indicates otherwise:

4 "(1) AUTOMATIC NUMBER IDENTIFICATION. An enhanced
5 911 service capability that enables the automatic display of
6 the 10-digit telephone number used to place a 911 call. The
7 term includes pseudo-automatic number identification, which
8 means an enhanced 911 service capability that enables
9 identification of the subscriber.

10 "(2) CMRS. Commercial mobile radio service under
11 Sections 3(27) and 332(d) of the Federal Telecommunications
12 Act of 1996, 47 U.S.C. §151 et seq., and Omnibus Budget
13 Reconciliation Act of 1993, Pub. L. 103-66, Aug. 10, 1993, 107
14 Stat. 312. The term includes the term wireless and service
15 provider by any wireless real time two-way voice communication
16 device, including radio-telephone communications used in
17 cellular telephone service, personal communication service, or
18 the functional or competitive equivalent of a radio-telephone
19 communications line used in cellular telephone service, a
20 personal communication service, or a network radio access
21 line. The term does not include service whose customers do not
22 have access to 911 or to an enhanced 911-like service, to a
23 communications channel suitable only for data transmission, to
24 a wireless roaming service or other non-local radio access
25 line service, or to a private telecommunications system.

1 "(3) CMRS CONNECTION. Each mobile telephone number
2 assigned to a CMRS subscriber with a place of primary use in
3 Alabama.

4 "(4) CMRS PROVIDER. A person or entity that provides
5 CMRS.

6 "~~(1)~~ (5) CREATING AUTHORITY. The municipal governing
7 body of any municipality or the governing body of any county
8 that, by passage of a resolution or ordinance, creates a
9 ~~communication~~ district within its respective jurisdiction in
10 accordance with this chapter.

11 "(6) DISTRIBUTION FORMULA. The percentage of the
12 total state population residing in a district, compared to the
13 total state population residing in all districts statewide,
14 based upon the latest census data or estimates compiled by or
15 for the Alabama Department of Economic and Community Affairs.

16 "~~(2)~~ (7) DISTRICT. ~~The~~ A communication district
17 created pursuant to this chapter.

18 "~~(3) E911. Enhanced universal emergency number~~
19 ~~service or enhanced 911 service which is a telephone exchange~~
20 ~~communications service whereby a public safety answering point~~
21 ~~(PSAP) designated by the customer may receive telephone calls~~
22 ~~dialed to the telephone number 911. E911 service includes~~
23 ~~lines, facilities, and equipment necessary for answering,~~
24 ~~transferring, and dispatching public emergency telephone calls~~
25 ~~originated by persons within the serving area who dial 911 but~~

1 ~~E911 service does not include dial tone first which may be~~
2 ~~made available by the service provider based on the ability to~~
3 ~~recover the costs associated with its implementation and~~
4 ~~consistent with tariffs filed with and approved by the Alabama~~
5 ~~Public Service Commission.~~

6 ~~"(4) EXCHANGE ACCESS FACILITIES. All lines, provided~~
7 ~~by the service suppliers for local exchange service, as~~
8 ~~defined in existing general subscriber services tariffs.~~

9 ~~"(5) PRIVATE SAFETY AGENCY. Any other for profit or~~
10 ~~not for profit entity providing emergency fire, ambulance,~~
11 ~~rescue, emergency management, or emergency medical services.~~

12 "(8) ENHANCED 911, E-911, or E-911 SYSTEM. An
13 emergency telephone system that directs 911 calls to
14 appropriate public safety answering points by selective
15 routing based on the geographical location from which the call
16 originated, that provides the capability for automatic number
17 identification, and the features that the Federal
18 Communications Commission may require in the future. Such
19 system may include lines, facilities, and equipment necessary
20 for answering, transferring, and dispatching public emergency
21 telephone calls originated by persons within the service area
22 who dial 911 but does not include dial tone first which may be
23 made available by the service provider based on the ability to
24 recover the costs associated with its implementation and, to

1 the extent required by law, consistent with tariffs with and
2 approved by the Alabama Public Service Commission.

3 "(9) FCC ORDER. The order of the Federal
4 Communications Commission, FCC Docket No. 94-102, adopted on
5 June 12, 1996, and released on July 26, 1996.

6 "(10) OTHER ORIGINATING SERVICE PROVIDER. An entity
7 other than a voice communication service provider that
8 delivers real-time communication between a person needing
9 assistance and an E-911 system.

10 "(11) PHASE II ENHANCED 911. An enhanced 911 system
11 that identifies the location of all 911 calls by longitude and
12 latitude in conformance with accuracy requirements established
13 by the Federal Communications Commission.

14 "(12) PLACE OF PRIMARY USE. The street address
15 representative of where the customer's use of the mobile
16 telecommunications service primarily occurs, which must be:

17 "a. The residential street address or the primary
18 business street address of the customer.

19 "b. Within the licensed service areas of the CMRS
20 provider.

21 "(13) PUBLIC SAFETY AGENCY. An agency of the
22 State of Alabama, or a functional division of a political
23 subdivision, that provides fire fighting, rescue, natural or
24 man-caused disaster, or major emergency response, law
25 enforcement, ambulance, or emergency medical services.

1 ~~"(7) SERVICE SUPPLIER. Any person providing exchange~~
 2 ~~telephone service to any service user throughout the county or~~
 3 ~~municipality.~~

4 ~~"(8) SERVICE USER. Any person, not otherwise exempt~~
 5 ~~from taxation, who is provided exchange telephone service in~~
 6 ~~the municipality or county.~~

7 ~~"(9) TARIFF RATE. The rate or rates billed by a~~
 8 ~~service supplier as stated in the service supplier's tariffs~~
 9 ~~and approved by the Alabama Public Service Commission, which~~
 10 ~~represent the service supplier's recurring charges for~~
 11 ~~exchange access facilities, exclusive of all taxes, fees,~~
 12 ~~licenses, or similar charges whatsoever.~~

13 ~~"(10) UNIFORM APPLICATION. The rate to be charged or~~
 14 ~~applied by the communication district to the exchange access~~
 15 ~~rate charged to business and residential access lines.~~

16 "(14) STATEWIDE 911 BOARD or 911 BOARD. The
 17 statewide 911 Board established pursuant to Section 11-98-4.1.

18 "(15) STATEWIDE 911 CHARGE. The statewide 911 charge
 19 created pursuant to Section 11-98-5.

20 "(16) SUBSCRIBER. A person who purchases a voice
 21 communications service and is able to receive it or use it
 22 periodically over time; provided, however, that for purposes
 23 of the imposition and collection of the statewide 911 charge
 24 the term subscriber shall not include the State of Alabama,
 25 the counties within the state, incorporated municipalities of

1 the State of Alabama, county and city school boards,
2 independent school boards, and all educational institutions
3 and agencies of the State of Alabama, the counties within the
4 state, or any incorporated municipalities of the State of
5 Alabama.

6 "(17) TECHNICAL PROPRIETARY INFORMATION. Technology
7 descriptions, technical information, or trade secrets,
8 including the term trade secrets as defined by the Alabama
9 Trade Secrets Act of 1987, Chapter 27 of Title 8, and the
10 actual or developmental costs thereof which are developed,
11 produced, or received internally by a voice communications
12 service provider or by its employees, directors, officers, or
13 agents.

14 "(18) VOICE COMMUNICATIONS SERVICE. Any of the
15 following:

16 "a. The transmission, conveyance, or routing of
17 real-time, two-way voice communications to a point or between
18 or among points by or through any electronic, radio,
19 satellite, cable, optical, microwave, wireline, wireless, or
20 other medium or method, regardless of the protocol used.

21 "b. The ability to receive and terminate voice calls
22 to and from the public switched telephone network.

23 "c. Interconnected VoIP service, as that term is
24 defined by 47 C.F.R. § 9.3.

1 "d. Such other services to which the statewide 911
 2 charge is applied pursuant to Section 11-98-4.1(e)(8).

3 "(19) VOICE COMMUNICATIONS SERVICE PROVIDER. An
 4 entity that provides voice communications service to a
 5 subscriber in the State of Alabama.

6 "(b) The terms department, prepaid retail,
 7 transaction, prepaid wireless telephone service, and prepaid
 8 wireless consumer shall have those meanings ascribed to them
 9 in Section 11-98-5.3.

10 "§11-98-2.

11 "The creating authority may by ordinance or
 12 resolution, as may be appropriate, create within its
 13 respective jurisdiction ~~communications~~ districts composed of
 14 the territory lying wholly within the municipality or of any
 15 part or all of the territory lying wholly within the county.
 16 The districts shall be political and legal subdivisions of the
 17 state, with power to sue and be sued in their corporate names
 18 and to incur debt and issue bonds. The bonds shall be
 19 negotiable instruments and shall be solely the obligations of
 20 the district and not the State of Alabama. The bonds and the
 21 income thereof shall be exempt from all taxation in the State
 22 of Alabama. The bonds shall be payable out of the income,
 23 revenues, and receipts of the district. The bonds shall be
 24 authorized and issued by resolution or ordinance of the
 25 creating authority of the district and shall be of such

1 series, bear such date or dates, mature at such time or times,
2 not to exceed 30 years from issuance, bear interest at such
3 rate or rates, be in such denominations, be in such form,
4 without coupon or fully registered without coupon, carry such
5 registration and exchangeability privileges, be payable in
6 such medium of payment and at such place or places, be subject
7 to such terms of redemption, and be entitled to the priorities
8 on the income, revenues, and receipts of the district as the
9 resolution or ordinance may provide.

10 "All bonds shall contain a recital that they are
11 issued pursuant to this chapter, which recitals shall be
12 conclusive that they have been duly authorized pursuant to
13 this chapter.

14 "§11-98-4.

15 "(a) When any district is created, the creating
16 authority may appoint a board of commissioners composed of
17 seven members to govern its affairs, and shall fix the
18 domicile of the board of commissioners at any point within the
19 district. In the case of county districts, after the
20 expiration of the terms of the members of the board of
21 commissioners holding office on May 23, 2000, there may be at
22 least one member of the board of commissioners from each
23 county commission district if the number of the county
24 commission does not exceed seven, unless a resolution dated
25 before January 1, 2000, was passed by a county commission

1 establishing an appointment process different from this
2 section or as otherwise provided by the enactment of a local
3 act after May 23, 2000. The members of the board of
4 commissioners shall be qualified electors of the district, two
5 of whom shall be appointed for terms of two years, three for
6 terms of three years, and two for terms of four years, dating
7 from the date of the adoption of the resolution or ordinance
8 creating the district. Thereafter, all appointments of the
9 members shall be for terms of four years.

10 "(b) The board of commissioners shall have complete
11 and sole authority to appoint a chairman and any other
12 officers it may deem necessary from among the membership of
13 the board of commissioners.

14 "(c) A majority of the board of commissioners
15 membership shall constitute a quorum and all official action
16 of the board of commissioners shall require a quorum.

17 "(d) The board of commissioners may employ such
18 employees, experts, and consultants as it deems necessary to
19 assist the board of commissioners in the discharge of its
20 responsibilities to the extent that funds are made available.

21 "(e) In lieu of appointing a board of commissioners,
22 the governing body of the creating authority may serve as the
23 board of commissioners of the district, in which case it shall
24 assume all the powers and duties of the board of commissioners
25 as provided in this chapter.

1 "(f) In addition to other authority and powers
2 necessary to establish, operate, maintain, and replace an
3 emergency communication system, the board of commissioners
4 shall have the following authority:

5 "(1) To sue and be sued, to prosecute, and defend
6 civil actions in any court having jurisdiction of the subject
7 matter and of the parties.

8 "(2) To acquire or dispose of, whether by purchase,
9 sale, gift, lease, devise, or otherwise, property of every
10 description that the board may deem necessary, consistent with
11 this section, and to hold title thereto.

12 "(3) To construct, enlarge, equip, improve,
13 maintain, and operate all aspects of an emergency
14 communication system consistent with subsection ~~(i)~~ (a) of
15 Section ~~11-98-5~~ 11-98-6.

16 "(4) To borrow money for any of its purposes.

17 "(5) To provide for such liability and hazard
18 insurance as the board of commissioners may deem advisable to
19 include inclusion and continuation, or both, of district
20 employees in state, county, municipal, or self-funded
21 liability insurance programs.

22 "(6) To enter into contracts or agreements with
23 public or private safety agencies for dispatch services when
24 such terms, conditions, and charges are mutually agreed upon,
25 unless otherwise provided by local law.

1 "(7) To make grants to ~~smaller~~ municipalities for
2 dispatching equipment and services.

3 "(g) The board of commissioners may elect to form a
4 nonprofit, public corporation with all of the powers and
5 authority vested in such political and legal entities. The
6 certificate of incorporation shall recite, in part:

7 " (1) That this is a nonprofit, public corporation
8 and is a political and legal subdivision of the State of
9 Alabama as defined in this chapter.

10 " (2) The location of its principal office.

11 " (3) The name of the corporation.

12 " (4) That the governing body is the board of
13 commissioners.

14 " (h) Any other provisions of this chapter
15 notwithstanding, the board of commissioners shall present to
16 the creating authority for approval the acquisition,
17 disposition, or improvements to real property.

18 " (i) In addition to the provisions of subdivision
19 (5) of subsection (f), each employee or official of the
20 district who receives funds or is involved in the disbursement
21 of funds in any manner shall be bonded in an amount not less
22 than the amount of total funds received by the district in the
23 prior fiscal year. The bonds shall be paid for by the
24 district, and a copy shall be on file at the offices of the

1 district and at the office of the judge of probate of the
2 county in which the district is incorporated.

3 "§11-98-5.

4 ~~"(a) (1) The board of commissioners of the district
5 may, when so authorized by a vote of a majority of the persons
6 voting within the district, in accordance with law, levy an
7 emergency telephone service charge in an amount not to exceed
8 five percent of the maximum tariff rate charged by any service
9 supplier in the district, except that in counties with
10 populations of less than 25,000 as determined by the most
11 recent population census, the board of commissioners may, when
12 so authorized by a vote of a majority of the persons voting
13 within the district, in accordance with law, levy an emergency
14 telephone service charge in an amount not to exceed two
15 dollars (\$2). The governing body of the municipality or county
16 may, upon its own initiative, call the special election. Any
17 service charge shall have uniform application and shall be
18 imposed throughout the entire district, to the greatest extent
19 possible, in conformity with availability of such service in
20 any area of the district. The district shall have service on
21 line no later than 36 months from the start of collections or
22 suspend all collections until the district provides the
23 service and shall refund all collections made during this 36
24 month period of time.~~

1 ~~"(2) On and after January 1, 1992, the board of~~
2 ~~commissioners, once so authorized by a vote of a majority of~~
3 ~~the persons voting in the district to levy an emergency~~
4 ~~telephone service charge, may implement any rate of the~~
5 ~~emergency telephone service charge permitted under this~~
6 ~~section, as it may be amended from time to time, without~~
7 ~~further authorization.~~

8 ~~"(b) If the proceeds generated by an emergency~~
9 ~~telephone service charge exceed the amount of moneys necessary~~
10 ~~to fund the district, the board of commissioners shall, by~~
11 ~~ordinance or resolution, as provided in this chapter, reduce~~
12 ~~the service charge rate to an amount adequate to fund the~~
13 ~~district. In lieu of reducing the service charge rate, the~~
14 ~~board of commissioners may suspend the service charge, if the~~
15 ~~revenues generated therefrom exceed the district's needs. The~~
16 ~~board of commissioners may, by resolution or ordinance,~~
17 ~~reestablish the original emergency telephone service charge~~
18 ~~rate, or lift the suspension thereof, if the amount of moneys~~
19 ~~generated is not adequate to fund the district.~~

20 ~~"(c) An emergency telephone service charge shall be~~
21 ~~imposed only upon the amount received from the tariff rate for~~
22 ~~exchange access lines. If there is no separate exchange access~~
23 ~~charge stated in the service supplier's tariffs, the board of~~
24 ~~commissioners shall determine a uniform percentage not in~~
25 ~~excess of 85 percent of the tariff rate for basic exchange~~

1 ~~telephone service that shall be deemed to be the equivalent of~~
2 ~~tariff rate exchange access lines, until the service supplier~~
3 ~~establishes the tariff rate. No service charge shall be~~
4 ~~imposed upon more than 100 exchange access facilities per~~
5 ~~person, per location. Every billed service user shall be~~
6 ~~liable for any service charge imposed under this subsection~~
7 ~~until it has been paid to the service supplier. The duty of~~
8 ~~the service supplier to collect the service charge shall~~
9 ~~commence upon the date of its implementation, which shall be~~
10 ~~specified in the resolution calling the election. That~~
11 ~~emergency telephone service charge shall be added to and may~~
12 ~~be stated separately in the billing by the service supplier to~~
13 ~~the service user.~~

14 ~~"(d) The service supplier shall have no obligation~~
15 ~~to take any legal action to enforce the collection of any~~
16 ~~emergency telephone service charge. The service supplier shall~~
17 ~~quarterly provide the board of commissioners with a list of~~
18 ~~the amount uncollected, together with the names and addresses~~
19 ~~of those service users who carry a balance that can be~~
20 ~~determined by the service supplier to be nonpayment of the~~
21 ~~service charge. The service charge shall be collected at the~~
22 ~~same time as the tariff rate according to the regular billing~~
23 ~~practice of the service supplier. Good faith compliance by the~~
24 ~~service supplier shall constitute a complete defense to any~~
25 ~~legal action or claim that may result from the service~~

1 ~~supplier's determination of nonpayment or the identification~~
2 ~~of service users, or both.~~

3 ~~"(e) The amounts collected by the service supplier~~
4 ~~attributable to any emergency telephone service charge shall~~
5 ~~be due monthly. The amount of service charge collected in one~~
6 ~~calendar month by the service supplier shall be remitted to~~
7 ~~the district no later than 30 days after the close of a~~
8 ~~calendar month. On or before the thirtieth day after the close~~
9 ~~of a calendar month, a return, in the form the board of~~
10 ~~commissioners and the service supplier agree upon, shall be~~
11 ~~filed with the district, together with a remittance of the~~
12 ~~amount of service charge collected payable to the district.~~
13 ~~The service supplier shall maintain records of the amount of~~
14 ~~the service charge collected for a period of at least two~~
15 ~~years from the date of collection. The board of commissioners~~
16 ~~may, at its expense, require an annual audit of the service~~
17 ~~supplier's books and records with respect to the collection~~
18 ~~and remittance of the service charge. From the gross receipts~~
19 ~~to be remitted to the district, the service supplier shall be~~
20 ~~entitled to retain an administrative fee in an amount equal to~~
21 ~~one percent.~~

22 ~~"(f) In order to provide additional funding or~~
23 ~~additional real or personal property for the district, the~~
24 ~~district or county or municipal governing body may receive~~
25 ~~federal, state, county, or municipal real or personal property~~

1 ~~and funds, as well as real or personal property and funds from~~
2 ~~private sources, and may expend the funds or use the property~~
3 ~~for the purposes of this chapter.~~

4 ~~"(g) With the agreement of the service supplier and~~
5 ~~the creating authority, two or more communication districts,~~
6 ~~or cities, or counties, or a city and a county in another~~
7 ~~communication district may agree to cooperate, to the extent~~
8 ~~practicable, to provide funding and service to their~~
9 ~~respective areas, and a single board of commissioners of not~~
10 ~~more than seven members may be appointed to conduct the~~
11 ~~affairs of the entities involved.~~

12 ~~"(h) A district may expend available funds to~~
13 ~~establish a common address and location identification program~~
14 ~~and to establish the emergency service number data base to~~
15 ~~facilitate efficient operation of the system. The governing~~
16 ~~body and the E-911 board of the county or city affected shall~~
17 ~~jointly be responsible for purchasing and installing the~~
18 ~~necessary signs to properly identify all roads and streets in~~
19 ~~the district.~~

20 ~~"(i) Funds generated from emergency telephone~~
21 ~~service charges shall be used to establish, operate, maintain,~~
22 ~~and replace an emergency communication system that may,~~
23 ~~without limitation, consist of the following:~~

24 ~~"(1) Telephone communications equipment to be used~~
25 ~~in answering, transferring, and dispatching public emergency~~

1 ~~telephone calls originated by persons within the service area~~
2 ~~who dial 911.~~

3 ~~"(2) Emergency radio communications equipment and~~
4 ~~facilities necessary to transmit and receive "dispatch" calls.~~

5 ~~"(3) The engineering, installation, and recurring~~
6 ~~costs necessary to implement, operate, and maintain an~~
7 ~~emergency communication system.~~

8 ~~"(4) Facilities to house E-911 services as defined~~
9 ~~in this chapter, with the approval of the creating authority,~~
10 ~~and for necessary emergency and uninterruptable power supplies~~
11 ~~for the systems.~~

12 "(a) A single, monthly statewide 911 charge shall be
13 imposed on each active voice communications service connection
14 in Alabama that is technically capable of accessing a 911
15 system. For CMRS providers, the statewide 911 charge shall be
16 levied on each CMRS connection with a primary place of use in
17 the State of Alabama. The statewide 911 charge is payable by
18 the subscriber to the voice communications service provider.
19 Except as otherwise provided in this chapter, the voice
20 communications service provider shall list the statewide 911
21 charge separately from other charges on the bill and the
22 charge shall be collected according to the regular billing
23 practice of the voice communications service provider. The
24 statewide 911 charge collected under this section shall not be
25 subject to taxes or charges levied on or by the voice

1 communications service provider nor shall the charges and fees
2 be considered revenue of the voice communications service
3 provider for any purposes. Partial payments made by a
4 subscriber are applied first to the amount owed for voice
5 communications service. The 911 Board shall collect from each
6 voice communications service provider the monthly statewide
7 911 charges prescribed herein. The initial statewide 911
8 charge shall be developed by the 911 Board at an amount
9 calculated to produce, after deduction of administrative fees
10 specified in this chapter, annual total revenues equal to the
11 annual 911 fees collected by or on behalf of, or owed to,
12 districts and governmental bodies, as calculated for purposes
13 of the base distribution amount under subdivision (3) of
14 subsection (b) of Section 11-98-5.2, plus, without
15 duplication, (1) the amount of CMRS service charges collected
16 by the CMRS Board for the 12 months ending September 30, 2011,
17 and (2) an amount equal to any other taxpayer funding of E-911
18 systems by counties or municipalities in areas where no
19 separate 911 fee is imposed. The revenues and other funds used
20 to determine the initial statewide 911 charge shall be
21 hereafter referred to as the baseline 911 revenues. The
22 statewide 911 charge shall be uniformly applied and shall be
23 imposed throughout the state, and shall replace all other 911
24 fees or 911 taxes. The 911 Board shall certify that the
25 initial statewide 911 charge adopted herein is reasonably

1 calculated so as not to exceed the funding requirements of
2 this act. The board shall submit the recommended statewide 911
3 charge to the Permanent Oversight Commission for review and
4 approval no later than March 1, 2013. The Permanent Oversight
5 Commission may reject the recommended statewide 911 charge and
6 specify an alternative charge, calculated in accordance with
7 this chapter, by an affirmative vote of six of its members;
8 provided, however, in no case may the Permanent Oversight
9 Commission establish a rate which reduces funding below that

23 subject to further review by the Permanent Oversight

25 2013. Failure of the 911 Board to reject or modify the

1 alternative charge submitted by the Permanent Oversight
2 Commission within 30 days of submission shall result in the
3 alternative charge being deemed approved for implementation on

3 "(1) Invoices shall be sworn.

4 "(2) All costs and expenses must be commercially
5 reasonable.

6 "(3) All invoices for reimbursement shall be
7 directly related to compliance with the requirements of
8 enhanced 911 service.

9 "(4) The board shall adopt rules providing for prior
10 approval of any expenditures for which the CMRS provider
11 intends to seek reimbursement in excess of a threshold amount.

12 "(5) All invoices shall be supported by such
13 reasonable supporting document as required by the board and
14 shall be subject to audit.

15 "(b) If the total amount of invoices submitted to
16 the 911 Board and approved for payment in a month exceeds the
17 amount available from the 911 Fund for reimbursements to CMRS
18 providers, the amount payable to each CMRS provider shall be
19 reduced proportionately so that the amount paid does not
20 exceed the amount available for payment. The balance of the
21 payment is deferred to the following month. A deferred payment
22 accrues interest at a rate equal to the rate earned by the 911
23 Fund until it is paid.

24 "§11-98-9.

1 "All technical proprietary information submitted to
2 the board or to the independent third-party auditor as
3 provided by Section ~~11-98-7(b)(5)~~ 11-98-13 shall be retained
4 by the board and the auditor in confidence and shall be
5 subject to review only by the Examiners of Public Accounts.
6 Notwithstanding any other provision of the law, no technical
7 proprietary information submitted shall be subject to subpoena
8 or otherwise released to any person other than to the
9 submitting ~~CMRS~~ voice communication provider, the board, and
10 the independent third-party auditor without the express
11 permission of the administrator and the submitting ~~CMRS~~ voice
12 communication provider. General information collected by the
13 independent third-party auditor shall only be released or
14 published in aggregate amounts which do not identify or allow
15 identification of numbers of subscribers or revenues
16 attributable to an individual ~~CMRS~~ voice communication
17 provider. Notwithstanding any other provision of the law, no
18 district, political subdivision, ~~CMRS~~ voice communication
19 provider, ~~local exchange company~~, or ~~their~~ its employees,
20 directors, officers, or agents shall be liable for any damages
21 in a civil action or subject to criminal prosecution resulting
22 from death, injury, or loss to persons or property incurred by
23 any person in connection with establishing, developing,
24 implementing, maintaining, operating, and otherwise providing
25 ~~wireless-enhanced~~ 911 service in compliance with the

1 requirements established by the FCC ~~Order 94-102~~ and any rules
2 and regulations which are or may be adopted by the FCC
3 ~~pursuant to the order~~ or other state or federal requirement,
4 except in the case of willful or wanton misconduct."

5 Section 2. Sections 11-98-4.1, 11-98-5.2, 11-98-5.3,
6 11-98-13, 11-98-13.1, and 11-98-14 are added to the Code of
7 Alabama 1975, to read as follows:

8 §11-98-4.1.

9 (a) There is created a statewide 911 Board comprised
10 of 13 members that shall reflect the racial, gender,
11 geographic, urban/rural, and economic diversity of the state.
12 The 911 Board shall be created effective July 1, 2012, and
13 until the effective date of the statewide 911 charge pursuant
14 to Section 11-98-5, with cooperation of the CMRS Board, shall
15 plan for the implementation of the statewide 911 charge and
16 the distribution of the revenues as provided herein. The
17 reasonable administrative expenses incurred by the 911 Board
18 prior to the implementation of the statewide 911 charge may be
19 deducted from the existing CMRS Fund. Upon the effective date
20 of the new statewide 911 charge, the 911 Board shall replace
21 and supersede the CMRS Board formerly created pursuant to this
22 chapter, and the CMRS Fund shall be incorporated into, and
23 considered part of, the 911 Fund.

1 (b) The 13 members of the 911 Board, each of whom
2 shall serve for a term of four years, shall be appointed by
3 the Governor as follows:

4 (1) Seven members recommended by the Alabama
5 Association of 911 Districts, one from each of the seven
6 congressional districts, with each district representative
7 recommended selected by vote of the Alabama Association of 911
8 Districts members from that congressional district. The
9 initial appointments shall include the three district
10 representatives on the CMRS Board who shall serve through
11 March 31, 2014, and a member from the first, third, fifth, and
12 seventh congressional districts as provided herein. Following
13 the March 31, 2014, expiration of the terms of the district
14 representatives drawn from the CMRS Board, the Governor shall
15 appoint a member recommended by the Association of 911
16 Districts from each of the second, fourth, and sixth
17 congressional districts, it being the intent of this section
18 that each of the seven district representatives on the board
19 be from a different congressional district, as such districts
20 exist on the effective date of the act adding this section.

21 (2) Two members recommended by CMRS providers
22 licensed to do business in Alabama.

23 (3) Two members recommended by incumbent local
24 exchange carriers operating in Alabama, who shall not be from
25 the same local exchange carrier.

1 (4) Two members recommended by cable companies that
2 provide interconnected VoIP services in Alabama, who shall not
3 be from the same cable company.

4 (c) For purposes of the initial board appointments,
5 (1) five members of the board shall be appointed for a
6 four-year term; (2) four members for a three-year term; (3)
7 the three members of the CMRS Board who are appointed pursuant
8 to subdivision (1) of subsection (b) of Section 11-98-4.1 to
9 terms ending on March 31, 2014; and (4) the remaining member
10 for a two-year term. Thereafter, board members shall serve
11 staggered terms of four years. In the event of vacancy, the
12 vacancy shall be filled for the balance of the unexpired term
13 in the same manner as the original appointment. Any vacancy
14 occurring on the 911 Board, whether for an expired or
15 unexpired term, shall be filled by appointment as soon as
16 practicable after the vacancy occurs, whether for an expired
17 or unexpired term.

18 (d) For all terms expiring after July 1, 2015,
19 appointments made by the Governor shall be subject to
20 confirmation by the Senate as provided in this subsection.
21 Appointments made at times when the Senate is not in session
22 shall be effective immediately ad interim and shall serve
23 until the Senate acts on the appointment as provided herein.
24 Any appointment made while the Senate is not in session shall
25 be submitted to the Senate not later than the third

1 legislative day following the reconvening of the Legislature.
2 In the event the Senate fails or refuses to act on the
3 appointment, the person whose name was submitted shall
4 continue to serve until action is taken on the appointment by
5 the Senate.

6 (e) The statewide 911 Board shall have the following
7 powers and duties:

8 (1) To develop a 911 State Plan. In fulfilling this
9 duty, the 911 Board shall monitor trends in voice
10 communications service technology and in enhanced 911 service
11 technology, investigate, and incorporate Geographical
12 Information Systems (GIS) mapping and other resources into the
13 plan, and formulate recommended strategies for the efficient
14 and effective delivery of enhanced 911 service. In addition,
15 the board, in conjunction with the Permanent Oversight
16 Commission and utilizing the information developed by the
17 Department of Examiners of Public Accounts pursuant to Section
18 11-98-13.1, shall study the operational and financial
19 condition of the current 911 systems within the State of
20 Alabama and publish a report detailing the same; study the
21 rates charged for wireline 911 services and make adjustments
22 to the rates as provided in this chapter; recommend a
23 long-term plan for the most efficient and effective delivery
24 of 911 services in Alabama over both the long- and short-term;
25 recommend any legislation necessary to implement the long-term

1 plan; and report its recommendations to the Oversight
2 Commission no later than February 1, 2014.

3 (2) To administer the 911 Fund and the monthly
4 statewide 911 charge authorized by Section 11-98-5.

5 (3) To distribute revenue in the 911 Fund in
6 accordance with this chapter.

7 (4) To establish policies and procedures, adopted in
8 accordance with the Alabama Administrative Procedure Act, to
9 fund advisory services and training for districts and to
10 provide funds in accordance with these policies and procedures
11 to the extent funds are available.

12 (5) To make and enter into contracts and agreements
13 necessary or incidental to the performance of its powers and
14 duties under this chapter and to use revenue available to the
15 911 Board under Section 11-98-5 for administrative expenses to
16 pay its obligations under the contracts and agreements.

17 (6) To accept gifts, grants, or other money for the
18 911 Fund.

19 (7) To undertake its duties in a manner that is
20 competitively and technologically neutral as to all voice
21 communications service providers.

22 (8) To adopt rules in accordance with the
23 Administrative Procedure Act to implement this chapter; to
24 establish the statewide 911 charge; and, in response to
25 technological changes, apply, collect, and remit the statewide

1 911 charge, without duplication, to the active service
2 connections of other originating service providers that are
3 technically capable of accessing a 911 system, subject to the
4 provisions applicable to voice communications service
5 providers under this chapter. Any proposed rule extending the
6 application of the 911 charge beyond those voice communication
7 services defined in paragraphs a. to c., inclusive, of
8 subdivision (18) of Section 11-98-1, upon approval by the 911
9 Board shall be submitted to the Permanent Oversight Committee
10 which, by an affirmative vote of six of its members, may
11 disapprove the action. If not disapproved by the Permanent
12 Oversight Committee within 15 days of submission, the proposed
13 rule shall be deemed adopted by the 911 Board on the fifteenth
14 day after submission and shall be certified to the Legislative
15 Reference Service in accordance with the Administrative
16 Procedure Act. This authority does not include the regulation
17 of any 911 service, such as the establishment of technical
18 standards.

19 (9) To take other necessary and proper action to
20 implement this chapter.

21 §11-98-5.2.

22 (a) Effective October 1, 2013, the 911 Fund shall be
23 created as an insured interest-bearing account into which the
24 911 Board shall deposit all revenues derived from the service
25 charge levied on voice communications service providers under

1 this chapter and all prepaid wireless 911 charges received
2 from the department. The revenues deposited into the 911 Fund
3 shall not be monies or property of the state and shall not be
4 subject to appropriation by the Legislature. The 911 Board
5 shall administer the fund and shall credit the 911 Fund all
6 revenues received. The fund and revenues generated by the fund
7 may only be used as provided in this chapter.

8 (b) Effective October 1, 2013, there shall first be
9 deducted, no more than one time during each calendar month,
10 from the total amount of the statewide 911 charges paid over
11 to the 911 Board during such month, a sum not to exceed one
12 percent of the total amount, to be applied by the 911 Board
13 exclusively for payment of administrative expenses theretofore
14 incurred by it and, at the Board's discretion, the awarding of
15 additional operational grants to districts outside of the
16 other distribution criteria in this subsection upon a showing
17 of hardship. The balance of the total amount of the statewide
18 911 charges paid over to the 911 Board during each calendar
19 month shall be deposited into the 911 Fund and shall be
20 apportioned and distributed in accordance with the succeeding
21 provisions of this subsection.

22 (1) There shall be distributed each month among all
23 then existing districts, from the moneys then on deposit in
24 the 911 Fund, an aggregate amount equal to the sum of a. 80
25 percent of the portion of the statewide 911 charges remitted

1 to the 911 Board with respect to the month by CMRS providers
2 and for prepaid wireless 911 charges, plus b. 100 percent of
3 all other statewide 911 charges remitted to the 911 Board with
4 respect to the month.

5 (2) There shall be paid each month to each then
6 existing district, out of the amount described in subdivision
7 (1), one-twelfth of the sum of the base distribution amount
8 defined, as applicable, in subdivisions (3) and (4), plus the
9 per capita distribution amount defined in subdivision (5).

10 (3) The term base distribution amount, as used in
11 this section with respect to any district with a functioning
12 911 system as of September 30, 2011, and except as otherwise
13 provided in this subdivision and subdivision (4), means the
14 highest dollar amount per annum of emergency telephone service
15 charges, excluding any fees received from the CMRS Fund, if
16 any, received by the district during the five prior
17 consecutive fiscal years ending on September 30, 2011;
18 provided, that, if the district first levied any such service
19 charge, or if the district ~~increased the rate of the charge by~~
20 vote of the commissioners of the district, during the fiscal
21 year ending on September 30, 2011, or seven months thereafter,
22 increased the rate of the charge effective on or before
23 January 1, 2013 then the total dollar amount of the emergency
24 telephone service charges with respect to the fiscal year
25 ending September 30, 2011, shall be deemed to be the amount

1 that would have been collected had the increased rate been in
2 effect for the entire fiscal year ending September 30, 2011.
3 Any vote of the commissioners authorizing an increase in fees
4 under the preceding sentence may be contingent upon the
5 enactment of this bill. No adjustment shall be made under the
6 preceding sentence to take into account any increase in an
7 emergency service charge adopted by a district after January
8 1, 2012, if such district shall have otherwise increased its
9 emergency service charge since January 1, 2011. For any
10 district established prior to September 30, 2011, but which
11 initiated 911 service between September 30, 2011, and June 1,
12 2012, the base distribution amount shall be deemed to be the
13 amount that would have been collected if the 911 charge
14 imposed by the district on August 1, 2012, had been in effect
15 for the entire fiscal year. For any county or municipal
16 district that was funding an E-911 system on September 30,
17 2011, without a separate 911 fee, the base distribution amount
18 shall be the product of: That amount determined by the board
19 to be the county or municipality's total funding of its E-911
20 system for purposes of calculation of the initial statewide
21 rate under subsection (a) of Section 11-98-5, multiplied by a
22 fraction, the numerator of which is the total wireline 911
23 fees paid to all districts as of September 30, 2011, and the
24 denominator of which is the total wireline and wireless 911
25 fees determined by the board to have been paid to all

1 districts and the CMRS Board for the same period. Within 90
2 days of the effective date of any adjustment in the statewide
3 911 charge to increase the baseline 911 revenues under
4 subdivision (2) of subsection (c) of Section 11-98-5, the base
5 distribution amount shall be increased by an amount equal to
6 the product of: a. the total amount distributed to the
7 district in the immediately preceding fiscal year, multiplied
8 by b. the rate of growth, determined as a percentage, in the
9 CPI-U utilized by the 911 Board for the prior five year period
10 pursuant to subdivision (2) of subsection (c) of Section
11 11-98-5.

12 (4)a. Any district that has, prior to March 1, 2011,
13 entered into one or more contracts, including, without
14 limitation, any lease, lease-purchase, or purchase agreement
15 or contract, to acquire equipment utilized or to be utilized
16 as part of a single, comprehensive, countywide radio system to
17 be operated within the boundaries of the district, may, no
18 later than December 31, 2012, provide the 911 Board a copy of
19 a pro forma financial statement setting forth revenue and
20 expense projections demonstrating the ability of the district
21 to pay all principal and interest maturing or coming due with
22 respect to any contracts, and any bonds or other obligations
23 issued or incurred by the district to evidence the borrowing
24 of money by the district in connection with the planning,
25 acquisition, construction, and equipment of the countywide

1 radio system, and other system costs. Such revenue projections
2 shall set forth the district's annualized revenues that would
3 be included in the base distribution amount as calculated in
4 subdivision (3), for the fiscal year of the district ending on
5 September 30, 2011, or any fiscal year thereafter during which
6 the contracts, bonds, or other obligations are expected to be
7 outstanding and unpaid, and the amount received by the
8 district during the fiscal year ending September 30, 2011,
9 from the CMRS Fund. The pro forma statement shall be
10 accompanied by such supporting information as may be
11 reasonably requested by the 911 Board, whose review shall be
12 limited to the accuracy and reasonableness of the revenue and
13 expense projections contained therein solely for the purposes
14 of this subsection and which shall not extend to the approval
15 or disapproval of any projects authorized by the district
16 under existing law.

17 b. For a district meeting the requirements of this
18 subdivision, the base distribution amount for the district,
19 during any fiscal year or years in which the contracts, bonds,
20 or other obligations outstanding and unpaid, shall be
21 increased by the difference, if any, between the revenue
22 projections shown in the pro forma financial statement and the
23 base distribution amount as calculated under subdivision (3),
24 and the district's per capita distribution amount, as defined
25 in subdivision (5), shall be reduced by an amount equal to the

1 difference, with the amount of the reduction added to the
2 amount available for payment to other districts under
3 subdivision (5).

4 (5) The term per capita distribution amount, as used
5 in this section with respect to any district, means the
6 district's pro rata share, computed according to the
7 distribution formula, of the amount described in subdivision
8 (1) that remains after payment in full of the aggregate base
9 distribution amounts required to be paid to all districts.

10 (6) Notwithstanding the preceding provisions of this
11 subsection, there shall never be paid to any district, during
12 any fiscal year, from the moneys deposited into the 911 Fund,
13 an amount less than the sum of the total dollar amount of the
14 initial base distribution amount received by the district as
15 calculated under subdivision (3) of subsection (b) of Section
16 11-98-5.2 plus, without duplication, amount received by the
17 district from the CMRS Fund during the fiscal year ending
18 September 30, 2011. For any county or municipal district that
19 was funding an E-911 system on September 30, 2011, without a
20 separate 911 fee, there shall never be paid from the moneys
21 deposited into the 911 Fund, during any fiscal year, an amount
22 less than the sum that amount determined by the board to be
23 the county or municipality's funding of its E-911 system for
24 purposes of calculation of the initial statewide rate under
25 this section.

1 (7) Except as otherwise provided in subdivision (6),
2 there shall be set aside and deposited each month, into a
3 separate account, which may, but need not, form a part of the
4 911 Fund, an amount equal to 20 percent of the portion of the
5 statewide 911 charges remitted to the 911 Board with respect
6 to the month by CMRS providers. All moneys in the separate
7 account shall be used exclusively for payment of actual and
8 direct costs incurred by CMRS providers in complying with
9 wireless E-911 service requirements established by the FCC
10 Order and complying with any rules or regulations adopted at
11 any time by the FCC pursuant to the FCC Order; and the costs
12 may include, without limitation, costs and expenses incurred
13 in connection with designing, upgrading, purchasing, leasing,
14 programming, installing, testing, or maintaining all necessary
15 data, hardware, and software required in order to provide
16 Phase II Enhanced 911, and the incremental costs of operating
17 Phase II Enhanced 911.

18 (c) Each CMRS provider wishing to participate in the
19 payments provided in subdivision (7) subsection (b) for
20 expenses related to providing Phase II Enhanced 911 shall
21 certify to the 911 Board that it does not then collect a
22 cost-recovery or other similar separate charge from its
23 customers. CMRS providers failing to provide the certification
24 by October 1 are ineligible to receive any payments until such
25 certificate is provided to the 911 Board. Any CMRS provider

1 electing to collect cost-recovery or other similar separate
2 charges at any time following its October 1 certification
3 shall immediately notify the 911 Board and are ineligible to
4 participate in the payments established in this subsection
5 until ceasing the collection from its customers and providing
6 the notice required herein. This requirement shall only apply
7 to payments for expenses related to providing Phase II
8 Enhanced 911.

9 (d) Any CMRS provider wishing to receive
10 reimbursement of costs under the guidelines established by
11 subsection (c) shall also comply with Section 11-98-7.

12 (e) In the event that there are wireless emergency
13 telephone services that cannot be efficiently performed at the
14 district level or there are expenses that cannot be properly
15 allocated at the district level, the 911 Board may determine
16 the smallest practical unit basis for joint implementation and
17 provide reimbursements in accordance with this section.

18 §11-98-5.3.

19 (a) As used in this section, the following words and
20 terms shall have the following meanings unless the context
21 clearly indicates otherwise:

22 (1) DEPARTMENT. The Department of Revenue for the
23 State of Alabama.

1 (2) PREPAID RETAIL TRANSACTION. The purchase of
2 prepaid wireless telecommunications service from a seller for
3 any purpose other than resale.

4 (3) PREPAID WIRELESS CONSUMER. A person who
5 purchases prepaid wireless telecommunications service in a
6 retail transaction.

7 (4) PREPAID WIRELESS TELEPHONE SERVICE. A service
8 that meets all of the following requirements:

9 a. Authorizes the purchase of CMRS, either
10 exclusively or in conjunction with other services.

11 b. Must be paid for in advance.

12 c. Is sold in units or dollars whose number or
13 dollar value declines with use and is known on a continuous
14 basis.

15 (b) Notwithstanding any other provision of this
16 chapter, the current CMRS emergency telephone service charge
17 established under subdivision (1) of subsection (b) of Section
18 11-98-7 and, upon its implementation, the replacement,
19 statewide 911 charge to be established under subsection (a) of
20 Section 11-98-5 shall be collected on prepaid wireless
21 telephone service on each retail transaction as follows:

22 (1) The prepaid wireless statewide 911 charge shall
23 be collected on prepaid wireless by the seller from the
24 prepaid wireless consumer with respect to each retail
25 transaction occurring in this state. The amount of the prepaid

1 wireless 911 charge shall be either separately stated on an
2 invoice, receipt, or other similar document that is provided
3 to the prepaid wireless consumer by the seller, or otherwise
4 disclosed to the prepaid wireless consumer. If a minimal
5 amount of prepaid wireless telephone service is sold for a
6 single, non-itemized price as part of the purchase of a
7 wireless communications device, the seller may elect not to
8 apply the prepaid communications charge to the initial
9 transaction. For these purposes, a service allotment
10 denominated as 10 minutes or less, or five dollars (\$5) or
11 less, is a minimal amount. If the seller elects to collect
12 such charge, it shall be treated as all other prepaid
13 communications charges under this chapter.

14 (2) For purposes of subdivision (1) of subsection
15 (b), a retail transaction that is effected in person by a
16 prepaid wireless consumer at a business location of the seller
17 shall be treated as occurring in this state if that business
18 location is in this state, and any other retail transaction
19 shall be treated as occurring in this state if the retail
20 transaction is treated as occurring in this state for purposes
21 of Chapter 23 of Title 40.

22 (3) The prepaid wireless 911 charge is the liability
23 of the prepaid wireless consumer and not of the seller or of
24 any provider, except that the seller shall be liable to remit
25 all prepaid wireless 911 charges that the seller collects from

1 prepaid wireless consumers as provided in subdivisions (6) and
2 (7) of this subsection, including all charges that the seller
3 is deemed to collect where the amount of the charge has not
4 been separately stated on an invoice, receipt, or other
5 similar document provided to the prepaid wireless consumer by
6 the seller.

7 (4) The amount of the prepaid wireless 911 charge
8 that is collected by a seller from a prepaid wireless
9 consumer, if the amount is separately stated on an invoice,
10 receipt, or other similar document provided to the prepaid
11 wireless consumer by the seller, shall not be included in the
12 base for measuring any tax, fee, surcharge, or other charge
13 that is imposed by this state, any political subdivision of
14 this state, or any intergovernmental agency.

15 (5) The prepaid wireless 911 charge shall be
16 increased or decreased, as applicable, upon any change to the
17 rate specified in subdivision (1) of subsection (b) of Section
18 11-98-7 or, upon its implementation, the statewide 911 charge.
19 The increase or decrease shall be effective on the effective
20 date of the change to the postpaid charge or, if later, the
21 first day of the first calendar month to occur at least 60
22 days after the enactment of the change to the rate specified
23 in subdivision (1) of subsection (b) of Section 11-98-7 or,
24 upon its implementation, the statewide 911 charge. The
25 department shall provide not less than 30 days of advance

1 notice of the increase or decrease on the department's
 2 website.

3 (6) Prepaid wireless 911 charges collected by
 4 sellers shall be remitted to the department at the times and
 5 in the manner provided by Chapter 23 of Title 40. The
 6 department shall establish registration and payment procedures
 7 that substantially coincide with the registration and payment
 8 procedures that apply to Chapter 23, Title 40.

9 (7) A seller shall be permitted to deduct and retain
 10 four percent of prepaid wireless 911 charges that are
 11 collected by the seller from prepaid wireless consumers.

12 (8) The audit and appeal procedures applicable to
 13 Chapter 23 of Title 40 shall apply to prepaid wireless 911
 14 charges.

15 (9) The department shall establish procedures by
 16 which a seller of prepaid wireless telecommunications service
 17 may document that a sale is not a retail transaction, which
 18 procedures shall substantially coincide with the procedures
 19 for documenting sales for resale transactions for sales and
 20 use tax purposes under Chapter 23 of Title 40.

21 (10) The department shall pay all remitted prepaid
 22 wireless 911 charges over to the Commercial Mobile Radio
 23 Services Board and, upon the effective date of the statewide
 24 911 charge, to the statewide 911 Board, within 30 days of
 25 receipt, for use by the board in accordance with the purposes

1 permitted by this chapter, after deducting an amount, not to
2 exceed two percent of collected charges, that shall be
3 retained by the department to reimburse its direct costs of
4 administering the collection and remittance of prepaid
5 wireless 911 charges.

6 (c) The enactment of this section does not
7 constitute an expression as to the application of the CMRS
8 service charge to prepaid service before the adoption of the
9 act adding this section.

10 §11-98-13.

11 On a biennial basis, if not more frequently, the 911
12 Board shall retain an independent, third-party auditor for the
13 purposes of receiving, maintaining, and verifying the accuracy
14 of any and all information, including all proprietary
15 information, that is required to be collected, or that may
16 have been submitted to the board by voice communication
17 providers and districts, and the accuracy of the collection of
18 the 911 service charge required to be collected.

5 h. Each district shall identify and specify in
6 detail how the 911 funds received by each district were spent
7 in each fiscal year. The Department of Examiners of Public
8 Accounts shall identify any areas of noncompliance with this
9 chapter.

10 i. Monthly charges paid to each telecommunications
11 service provider for both data base and network charges.

12 j. Each communications district that fails to
13 provide the information required by this section to the
14 Department of Examiners of Public Accounts by the deadline
