

BID SPECIFICATIONS FOR 110 PTO TRACTOR

SPECIFICATIONS

These specifications shall be construed as the minimum acceptable standards for a 110 PTO hp tractor. Should the manufacturer's current published data or specifications exceed these standards, the manufacturer's standards shall be considered minimum and shall be furnished. All integral parts not specifically mentioned in the scope of these specifications that are necessary to provide a complete working unit shall be furnished. Additionally, the machine offered for bid shall include all standard manufacturer's equipment. The tractor must be a new current production model and shall meet all EPA and other applicable standards at time of manufacture.

The use of specific names and numbers in the specifications is not intended to restrict the bidder or any seller or manufacturer, but is intended solely for the purpose of indicating the type, size and quality of equipment considered best adapted to the uses of counties participating in this joint bid.

BID SUBMITTAL FORM

Each bidder must submit his or her bid on the Bid Submittal Form included in the invitation to bid package. All written warranties to be submitted shall be attached to the Bid Submittal Form.

BID PRICE

The price bid shall include all destination charges, delivery charges, title fees, rebates, and all other applicable costs and refunds.

MANUALS

Each unit shall be provided with one (1) copy of the operator's manual and one (1) copy of the current parts manual. Units will not be accepted for delivery until the manuals as outlined above are received by the purchaser.

REPLACEMENT PARTS AVAILABILITY

Parts must be available for 5 years or 7,500 hours of use for the piece of equipment bid. If replacement parts are not delivered within three (3) working days of an order being placed, the bidder will deliver an equivalent machine for the county to use at no cost to the county until such time as the parts are delivered to the county so it can affect repairs to its machine.

WARRANTY

Bidders shall submit a copy of the manufacturer's standard warranty along with a complete explanation of the warranty with their bid. The standard warranty shall cover 2 years or 2000 hours, whichever occurs first. Warranty shall include service response time maximum of 36 hours within notification by county.

Shall be a 4 Cylinder 4 stroke cycle turbocharged diesel engine with a displacement of not less than 276 cubic inches, capable of developing a minimum of 110 Net PTO horsepower and tier 4 compliant. A foot and hand operated throttle shall be provided. The engine shall be of a wet sleeve design with a cold weather starting aid.
