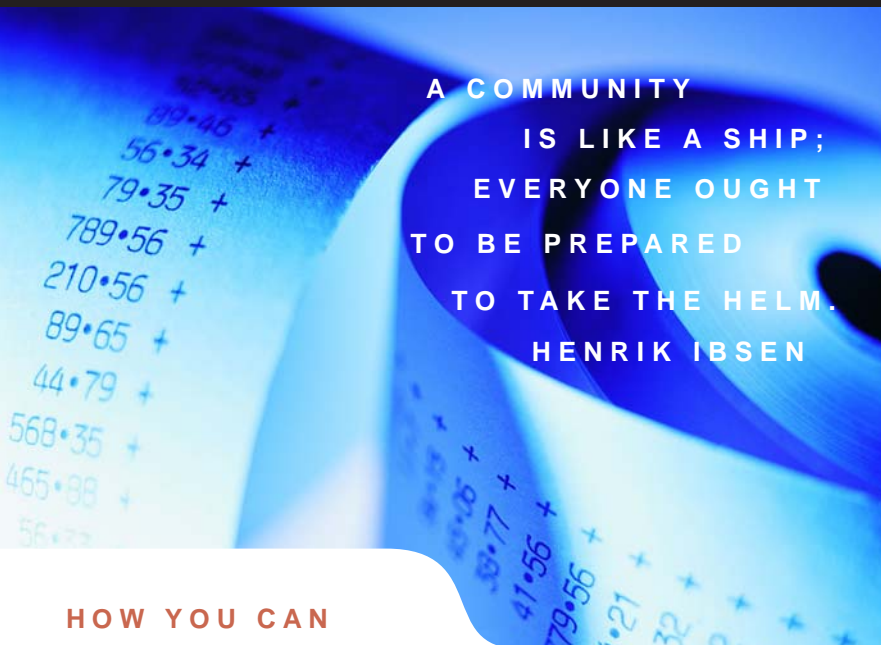

### HOW YOU CAN BECOME INVOLVED IN CROAA

As a Regular Member you are entitled to vote on matters such as the election of CROAA officers and directors, the ratification of annual dues, and any amendments to the Association's by-laws.

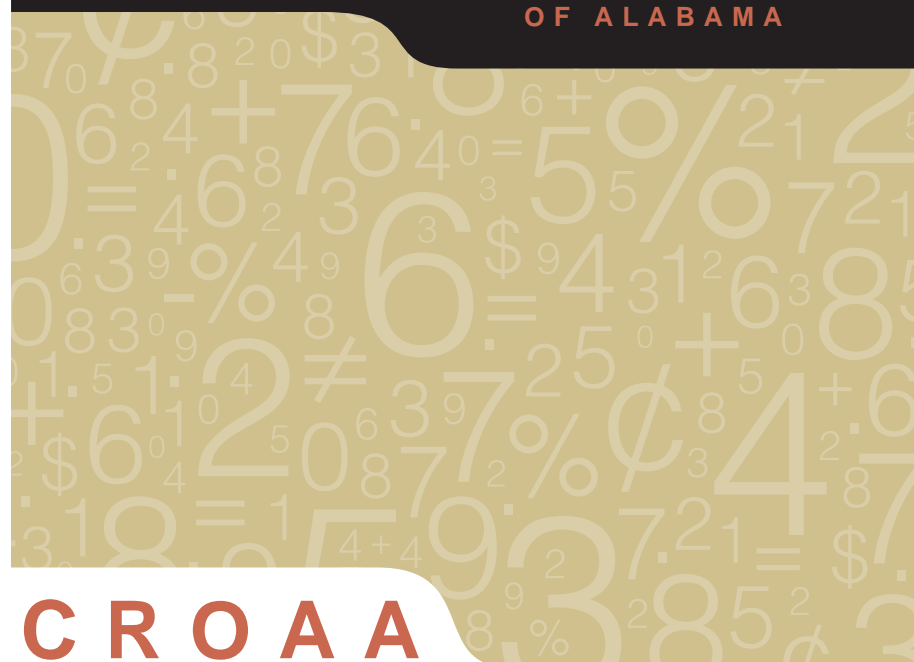
\_\_\_\_\_ **Associate Member** - Individuals, companies, or corporations (involved in the collection of local taxes or licenses or who support the purposes and goals of the Association), elected officials, State of Alabama employees, or faculty and staff of a higher education institution. Associate Members shall enjoy all rights and privileges of regular members but may not hold office or vote on Association matters.
