<u>Shelby County Annual Cost of Incarceration – County Jail = \$ 17,885 or \$49 Per Day</u>

This rate does not include onsite Behavioral Health Services and Offsite Medical Services

You cannot Solely Build your way out with County Jail Cells

Prior to 2004 = 74 Bed County Jail plus Two Portable Modular Housing Units (230 Inmates)

August 2004 = 534 Bed County Jail (Standard Housing 512, Segregation 14 and Medical 8)

August 2019 = $\underline{463}$ Inmates in County Jail (Breakdown: County 296, State 89, Federal 62, City 16 = 463)

Participants pay \$1,629,980 annually and \$802,299 comes from other sources = County General Funds, Local SCCHF, State DOC Contract, Supervised Visitation Exchange (Federal Grant/County Contract), OVW Grant/DV Court, AOC - DC/MHC/VTC Grants

I BEHAVIORAL HEALTH SERVICES ONSITE IN THE COUNTY JAIL ARE CRITICALLY IMPORTANT TO PUBLIC HEALTH AND SAFETY

Direct Impacts on Families, Victims, Offenders and Recurring Judicial / Correctional Requirements Since January 2019 Wellness Assessments – Covers both Mental Illness and Substance Use/Abuse

First 6 Months of 2019: **3,120** Adults Booked into the Shelby County Jail

• 744 screened positive for Mental Illness (MI) and/or Substance Use/Abuse (SU/A) Issues (24% of intakes) 279 Crisis/Clinical Screenings (Impacts Housing) performed with 295 Wellness Assessments Completed 226 of the 295 resulted in MI Treatment Needs and 80 resulted in SA Treatment Needs

Continuum of Care

• 312 individuals released from Jail have been contacted by CSMH / Follow-up concerning MI or SU/A Services (Case Manager) with 70 engaging CSMH services since being released from jail, 77 were connected with and received services through another Behavioral Health Provider and 21 individuals are currently receiving on-going case management services with a CSMH Case Manager
