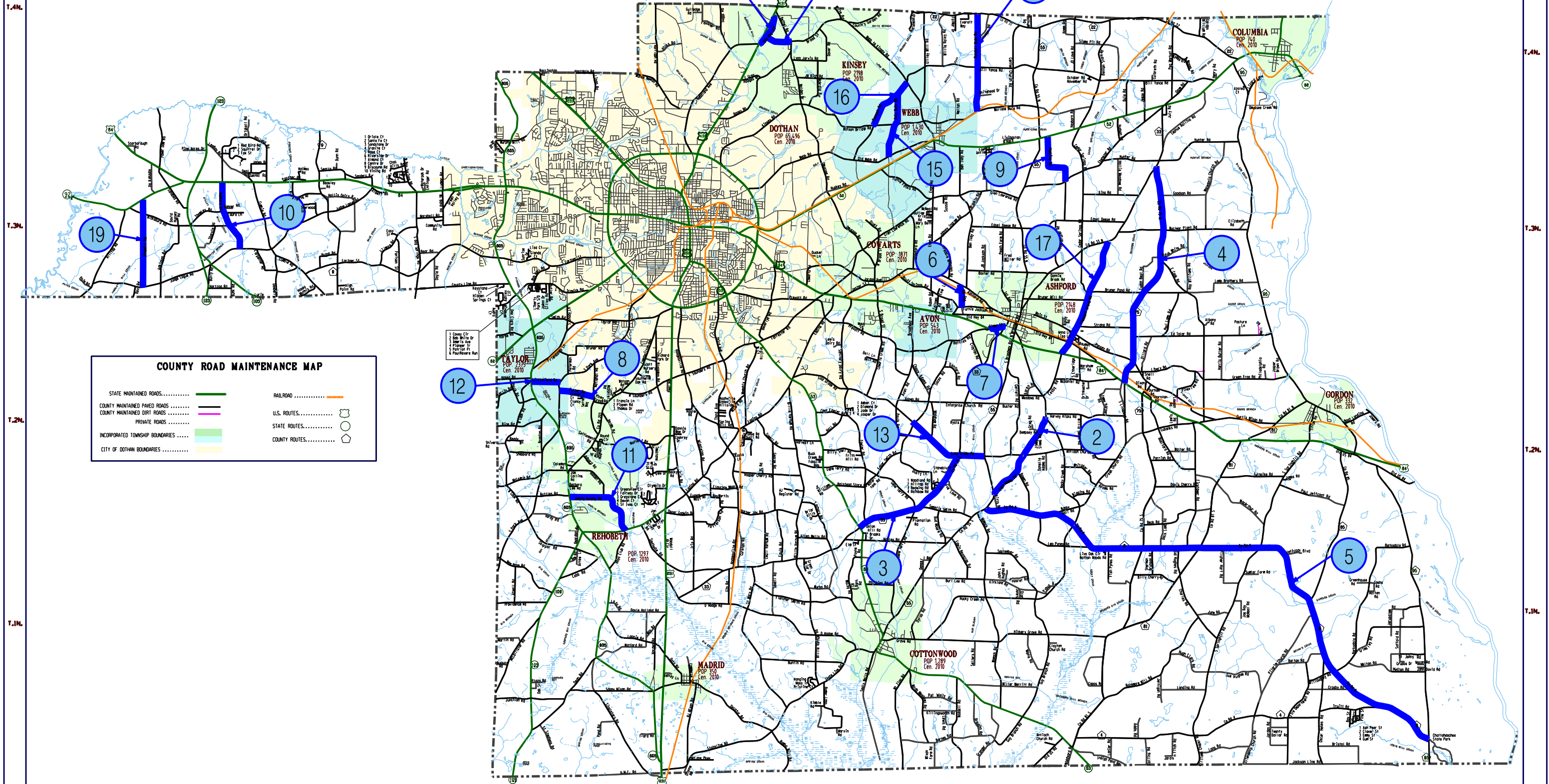

If total cost of projects exceed the Bond amount, CRAF funds will be utilized; any remaining CRAF balance and FAEF money will be carried over for future projects.
	** The towns of Ashford, Kinsey, Rehobeth and Taylor have signed agreements authorizing their 2020 CRAF revenue to be applied to County road projects within their town limits.
