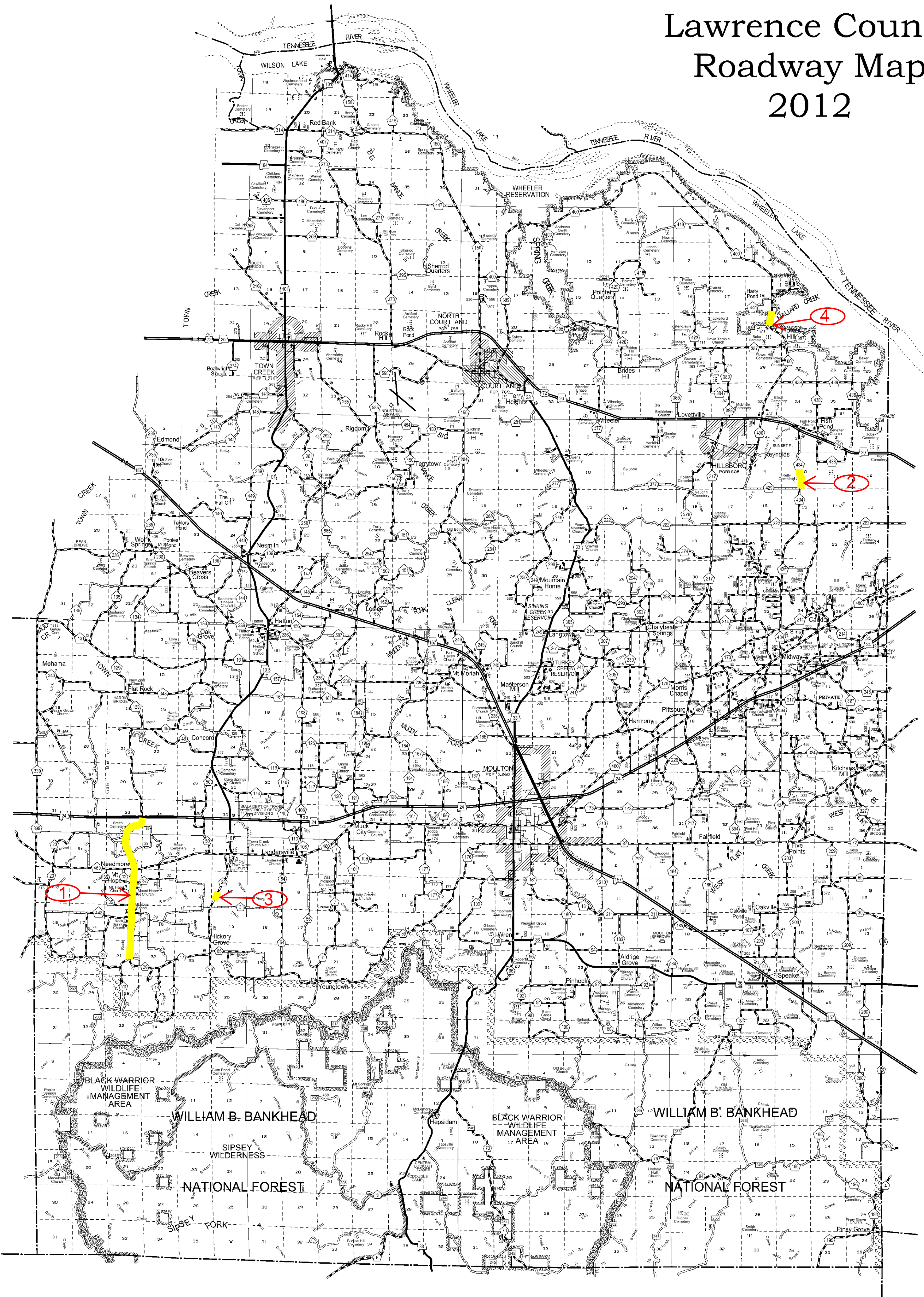

Remarks RA-LCP 40-02-2020 is a Federal Aid Project that will utilize \$720,000 of Federal Aid Funds and \$180,000 FAEF. RA-LCP 40-03-2020 is a ERPR Project that will utilize \$41,455.22 of Emergency Federal Relief Funds and \$10,363.81 FAEF. RA-LCP 40-04-2020 is a HRRR Project that will utilize \$42,610.11 of HRRR funds and \$4,734.46 FAEF.
The remaining estimated balance of CRAF and FAEF will be carried over for projects in next fiscal year's CTP.
