

Advertisement for Bid Jefferson County



Jefferson County is taking sealed bids for labor, equipment, materials, and any incidentals required to complete the work required for *Project Number* 37-19-404 (Group 2), Resurface and Traffic Stripe for the following roads:

- 1. Oxmoor Road From West Oxmoor Rd from Lakeshore Dr to Green Springs Hwy
- 2. Shannon Road From Highway 150 to Ross Bridge Parkway
- 3. Shannon Oxmoor Road From Ross Bridge Parkway to West Oxmoor
- 4. West Oxmoor Road From Shades Crest Road to City Limit Line
- 5. South Shades Crest Road From Morgan Road to Highway 150
- 6. Shades Crest Road From Highway 150 to West Oxmoor Road
- 7. Shades Crest Road From City Limit line to Rocky Ridge Road

This bid is intended to comply with the Rebuild Alabama Act, No. 2019-2, and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be marked with the word "BID" on the outside of the bid package along with "Bid Proposal for *Project Number 37-19-404*", the bid date and the Alabama General Contractor's License Number.

The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U.S. Government, the State of Alabama, any relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act.

Sealed bids will be received by the Jefferson County Commission at 716 Richard Arrington Jr. Blvd. N Suite A-200, Birmingham, AL 35203 until 2:00 PM Central Time on December 18, 2019, and then publicly opened as soon thereafter as practicable.
