
Note: Any amendments to the CTP shall follow the same guidelines and procedures as the original approval process.

^{*} The projects listed above will be paid for with a Bond; a maximum of one-half of each annual CRAF revenue will be applied to the Bond payment for the duration of the Bond (no more than

a 10-year Bond term). If total cost of projects exceed the Bond amount, CRAF funds will be utilized; any remaining CRAF balance and FAEF money will be carried over for future projects.

^{**} The town of Ashford has signed an agreement authorizing their 2021 CRAF revenue to be applied to County road projects within their town limits.
