


# RENEWAL ACCEPTANCE

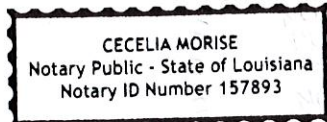

Dear Ms. Fuentes:

The Association of County Commissions of Alabama is presently preparing for the letting of bids for 2020-2021 under the Alabama County Joint Bid Program for disaster debris removal and debris monitoring services. However, rather than rebid all services awarded during last year's bid program, we would like to renew, to the extent possible, contracts entered into for 2019-2020, as provided in the original contracts.

The contracts executed in October 2018 with DRC Emergency Services, LLC for Regions 1, 2, 5, and 6 provide for renewal for a second and third year "under identical price, terms, and conditions upon the mutual consent of both parties if approved in writing by both parties no later than 90 days prior to the expiration of the existing contract." We would like to renew the contract entered into with DRC Emergency Services, LLC. The current contract will expire on October 31, 2020, if not renewed.

I am requesting that you respond to this offer to renew no later than July 31, 2020. If DRC Emergency Services, LLC is willing to renew any or all its contracts for another year under the identical terms and conditions, please complete and sign the attached Renewal Acceptance Form and return it to my attention no later than July 31, 2020. If the attached form is not received by that date, the Association will proceed with rebidding these services for the 2020-2021 year.
