Bids are to be based upon the cost per cubic yard to be picked up by Hale County personnel. In awarding a bid, as to this product, the Hale County Commission will consider mileage and labor cost. The successful bidder shall state whether or not their bid amount includes loading County trucks.

All materials furnished shall reasonably conform to the requirements of Soil Aggregate Base Course as stipulated in the State of Alabama Department of Transportation Standard Specifications for Highway Construction, 2012 Edition, and Supplemental Specifications and Special Provisions in effect at time of bid opening.
