### **TRAFFIC STRIPE & PAVEMENT MARKER BID**

Bids are hereby requested for furnishing traffic striping and pavement markers to Bibb County during the period October 25, 2021, through September 30, 2022. Bids will be opened October 22, 2021, at 10:00 AM in the Bibb County Commission Chambers in the County Commission Office located at 157 Southwest Davidson Dr in Centreville, Al 35042. The items will be furnished according to the attached pricing sheet and installed in accordance and within the timing specified in this document and in such quantities as may be ordered.

The bidder provided unit prices shall include all labor, materials, overhead, profit, insurance, testing, inspection charges, engineering, etc. to cover the completion of the work as required. Also, please provide expected completion date that all items shall be placed. All construction, materials, and testing shall conform to the Alabama Department of Transportation Standard Specifications for Highway Construction 2018 Edition.

The bidder understands that the County reserves the right to reject any and all bids and to waive any informalities involved in the bidding process. The quantities listed are approximate only. There will be no contract adjustments in the unit prices for any increase or decrease in the unit quantities. The bidder agrees that this bid shall be good for the time period October 25, 2021, through September 30, 2022 and may be extended for a period mutually agreed upon by Bibb County and the successful bidder not to exceed a total of four years.

Orders for work shall be completed within three (3) weeks from placement of such order. The successful bidder shall contact the Bibb County Engineering department at least 24 hours in advance prior to beginning work on any order. Also, the successful bidder shall send a representative to meet with a designated employee of the Bibb County Engineering Department to verify work location, quantities, etc. prior to beginning work on any order. Failure to carry out the above provisions may result in voiding of this bid/contract.

#### **Responsibility for Property Damage**

The contractor agrees to indemnify and hold harmless Bibb County and its agents from any damage or claims resulting from actions of the contractor or contractor's employees. The contractor shall be responsible for all damage to the right-of-way and fixtures within the right-of-way, as well as personal and private property, resulting from his operations. If damage occurs to adjacent property as the result of operations, the contractor shall be responsible for all repairs and/or other damages.

The Contractor will make contact with the person or persons registering a complaint within 24 hours and do whatever is necessary to investigate the situation and make a sound judgement as to its authenticity. If in fact, a liability situation does exist, every effort will be taken to ensure that the claim is settled as expeditiously as possible. In each case, Bibb County will be kept informed as to the disposition of complaints.

The Contractor will be responsible for any damage, personal or property, caused by the use of his equipment personnel, or vehicles while engaged in this contract. The Contractor will pay for and maintain in force during the tenure of this contract a minimum of the insurance listed below. Bibb County will be provided certified proof that such insurance is in force prior to the contract start work date and will continue in force for the length of the contract.

LIMITS

All complaints will be handled by the contractor within 24 hours of notice from Bibb County. Full records of complaints of damages will be kept by both the contractor and Bibb County. Bibb County will be informed in writing as to the disposition of all complaints as to their legitimacy and settlement. Bibb County will be added as an additional insured on the certificate of insurance provided under this contract.

Bids made out in pencil will not be accepted. The bid submission sheet must be notarized. Any attachment hereto is made and becomes a part of this inquiry and must be signed by bidder. No errors will be corrected after bids are opened. No prices shall include State or Federal Excise Taxes. Tax exemption certificates furnished upon request. County reserves the right to accept or reject all bids or any portion thereof.

#### **Bid Bond**

Each Bid Submission shall be accompanied by a bid bond made payable to the Bibb County Commission in the amount of five percent (5%) of the Total Bid Amount. Bidder shall submit the Bid Bond using the Bid Bond form attached.
