Randolph County is taking sealed bids for labor, equipment, materials, and any incidentals required to complete the work required for Project No. RA-RCP 56-262-21 (Site 1) Resurface CR-129 from SR-48 to River Point Drive, Project No. RA-RCP 56-263-21 (Site 2) Resurface CR-121 from CR-329 to US-431, Project No. RA-RCP 56-264-21 (Site 3) Resurface CR-123 from CR-256 to CR-121, Project No. RA-RCP 56-265-21 (Site 4) Resurface CR-16 from SR-22 to CR-59, Project No. RA-RCP 56-266-21 (Site 5) Resurface CR-3 from CR-8 to SR-22 and Project No. RA-RCP 56-267-21 (Site 6) Resurface CR-43 from CR-41 to CR-49, Randolph County. This bid is intended to comply with the Rebuild Alabama Act, No. 2019-2, and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.
