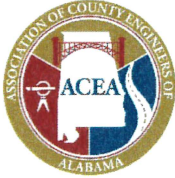
Dallas County is taking sealed bids for labor, equipment, materials, and any incidentals required to complete the work required for **Project DC 2022-12: For Resurfacing and Traffic Striping County Roads at the following sites:**

- **Site 1 RA-DCP 24-05-20** (0.83 mile portion of CR 209 from SR 14 to New Center Baptist Church)
- **Site 2 RA-DCP 24-11-21** (1.7 mile portion of CR 77 from US 80 to Anderson Ave)
- **Site 3 RA-DCP 24-01-22** (1.82 miles of Della Wages Subdivision and Anabel Hood Subdivision Streets including Choctaw Ave, Chickasaw Ave, Chickasaw Ave, Hood Ave, Idaho St, Utah St, Utah St 2, Utah St 3, Wages St)
- **Site 4 RA-DCP 24-02-22** (0.81 miles of Quail Ridge Subdivision Streets including Quail Hollow, Quail Ridge Dr., and Quail Run Dr.)
- **Site 5 RA-DCP 24-02-22** (1.23 miles of Valleyview Subdivision Streets including Valley View Dr. and Valleydale Dr.)
- **Site 6 RA-DCP 24-03-22** (1.5 mile portion of CR 28 from a point 0.42 mi west of Deer Ridge Drive and running west along CR 28 to a gate; Also a 300 ft spur on CR 219)
- **Site 7 DC 2022-11** (1.6 miles consisting of CR 162, CR 811 and a portion of CR 865)
- **Site 8 DC 2022-11** (0.3 mile portion of CR 347)
- **Site 9 DC 2022-12** (0.3 mile western segment of CR 820)
- **Site 10 RA-DCP 24-12-21** ("G" Treatment and Micro-Surface 6.4 mi of CR 39)

This bid is intended to comply with the Rebuild Alabama Act, No. 2019-2, and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be marked with the word "BID" on the outside of the bid package along with Bid Proposal for **Project DC 2022-12**, the bid date and the Alabama General Contractor's License Number.

The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U. S. Government, the State of Alabama, any relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act.
