Efficiency and Innovation in County Government: The Efficiency and Innovation in County Government award is a new award that will be presented during the Annual Convention's Awards Ceremony on Thursday, August 25. A spinoff of the former Excellence in County Government award, this award is designed to bring statewide attention to outstanding efforts by county government -- ranging from innovative approaches to industry recruitment to unique efforts at solving community problems.

Outstanding Contribution to County Government: This award is given annually to individuals who have contributed to the betterment of county government in a manner above and beyond what is expected in their everyday duties. It is not a longevity award, but represents significant contributions to county government statewide.

Tenure in Office Award: This award is given to County Commissioners who have served in office for at least 16 years. It is given to commemorate each year served, in multiples of four years. For example, a commissioner who will have completed his or her 16th, 20th, 24th, 28th or 32nd year of office following the general election in November is eligible for the award. *The Tenure in Office Award is given only to those who have completed a nomination form. Please submit a nomination form if your county has an eligible commissioner.*

Memorials: Memorials are issued by the ACCA for Commissioners who have passed away since August 2021 while in office. Please have your administrator complete this form if your county has lost a Commissioner during the past year.
