OTHER RESOLUTIONS

REQUESTING THE GOVERNOR'S ADMINISTRATION AND THE ALABAMA LEGISLATURE RENEW THE 2020 ALLOCATION OF \$26 MILLION IN CORONAVIRUS AID, RELIEF AND ECONOMIC SECURITY ACT FUNDS RESERVED FOR AND EXPENDED BY COUNTIES BUT REDIRECTED TO COVER OTHER STATE EXPENSES.

ENCOURAGING THE ALABAMA LEGISLATURE TO OPPOSE ANY LOCAL OR GENERAL LEGISLATION MAKING CHANGES TO THE SIMPLIFIED SELLERS USE TAX REMITTANCE ACT AND ITS DISTRIBUTION OF FUNDS PROVIDED TO COUNTIES FOR MAINTAINING CRITICAL SERVICES AT THE LOCAL LEVEL.

ENCOURAGING THE ALABAMA LEGISLATURE TO OPPOSE ANY INITIATIVES TO INCREASE THE WEIGHT LIMITS AND/OR ADJUST THE ALLOWABLE WEIGHT DISTRIBUTIONS FOR COMMERCIAL VEHICLES TRAVELING ON COUNTY ROADS AND BRIDGES.

ENCOURAGING A COMPREHENSIVE REVIEW OF ALABAMA'S PROCESS FOR REGISTERING VOTERS AND IMPLEMENTING DISTRICT REALIGNMENT, INCLUDING THE PROCESS FOR APPROVING MEMBERS OF THE BOARDS OF REGISTRARS.

ENCOURAGING A COMPREHENSIVE AND BROAD-BASED REVIEW OF THE DELIVERY OF AMBULANCE AND EMERGENCY RESPONSE SERVICES IN ALABAMA.
