Sealed bids for concrete pipe for a period of six (6) months, effective April 1, 2023, will be received by the Escambia County Commission at the Courthouse, 314 Belleville Avenue, Brewton, Alabama until 10:00 a.m., Wednesday, March 29, 2023.

All bids must be signed and sealed with the subject matter marked plainly on the outside of the envelope.

Concrete pipe shall conform to the current ALDOT Standard Specifications for Highway Construction and bidder shall furnish test reports certifying that the material meets ALDOT specs if requested.

Bids must specify price per linear foot and include delivery to job sites within Escambia County. Any exceptions must be clearly stated by the Vendor in a separate attachment.

All bidders must use the attached Bid Submission Form and each bid shall be filled out in ink. Bid prices are to cover a six (6) month period effective April 1, 2023.

The contract shall cover the County's needs from April 1, 2023 through September 30, 2023 with an option to issue a second and third six (6) month contract under the same pricing, terms, and conditions. The second and third contract, if requested by the County and agreed upon by the vendor, would begin the day after the first or second contract expires. Any successive contract must have written approval of both the County and the vendor no later than seven (7) days prior to the expiration of the previous contract.
