

ADVERTISEMENT FOR BIDS

Sealed bids for the construction of resurfacing and traffic stripe on Starhope Church Road, CDBG Project No. CY-CM-PF-22-007 will be received by the Crenshaw County Commission, at the Crenshaw County Highway Department, Luverne, AL 36049, until 2:00 o'clock p.m., October 18, 2023, and then publicly opened and read aloud at said location.

Principal items of work include leveling the roadway with approximately 930 tons of asphalt, placing approximately 28,630 square yards of triple surface treatment and placing traffic stripe.

Plans and specifications may be examined at the Crenshaw County Highway Department, 243 Justice Ave., Luverne, AL 36049.

A Pre-Bid Conference will be held at the Crenshaw County Highway Department on October 11, 2023, at 10:00 AM. All Prospective Bidders are encouraged to attend, but not required.

Copies of the plans and specifications may be obtained at the Crenshaw County Highway Department, 243 Justice Ave., Luverne, Alabama, upon deposit of \$50.00 for each set. The deposit will be refunded provided the plans and specifications are returned in reusable condition within 10 days of the bid opening.

All bids shall be submitted in the Contract Specification Book issued by the Engineer. Bids not submitted in the Contract Specification Book will not be opened. All bids must be submitted in a sealed envelope bearing on the outside the name of the bidder, bidder's license number, address and name of the project. If forwarded by mail, the sealed envelope containing the bid must be enclosed in another envelope addressed as specified in the bid form.

All contractors preparing bids for the referenced project shall maintain a current Alabama Contractor's License. If requested, a contractor shall provide a letter from the Office of the Alabama Secretary of State confirming registration. If evidence cannot be provided by the contractor, the contractor's bid will be rejected.

The Owner reserves the right to reject any or all bids and to waive any informalities, or to reject any or all bids, and to award the contract to the lowest, responsive bidder. All bidders shall submit, upon request, a list of projects "successfully completed" in the last 2 years, having the same scope of work and approximate construction cost as specified in the project. All bidders must comply with requirements of the Contractor's Licensing Law of the State of Alabama and be certified for the type of work on which the proposal is submitted. Each bidder must deposit with his bid, security in the amount, form and subject to the conditions provided in the Information for Bidders. The successful bidder will be required to submit 100% performance and payment bonds.

All bidders must comply with the President's Executive Order Number 11246 which prohibits discrimination in employment regarding race, creed, color, sex or national origin. All bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, the Anti-Kickback Act and the Contract Workhours Act.

Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the contract. This project is financed in part by CDBG Grant No. CY-CM-PF-22-007.

No bidder may withdraw his bid within 30 days after the actual date of the opening thereof.
