## Remarks

Any additional funds needed to complete projects will utilize separate funds. The remaining estimated balance of CRAF and FAEF will be carried over for projects in next fiscal year's CTP.

\*Some of the projects listed above will be paid for with a bond; a maximum of one-half of each annual CRAF revenue will be applied to the bond payment. The remaining CRAF balance and FAEF money will be carried over for future projects.
