* A maximum of one-half of each annual CRAF revenue will be applied to the Bond payment for the previous RA projects paid for with said Bond.

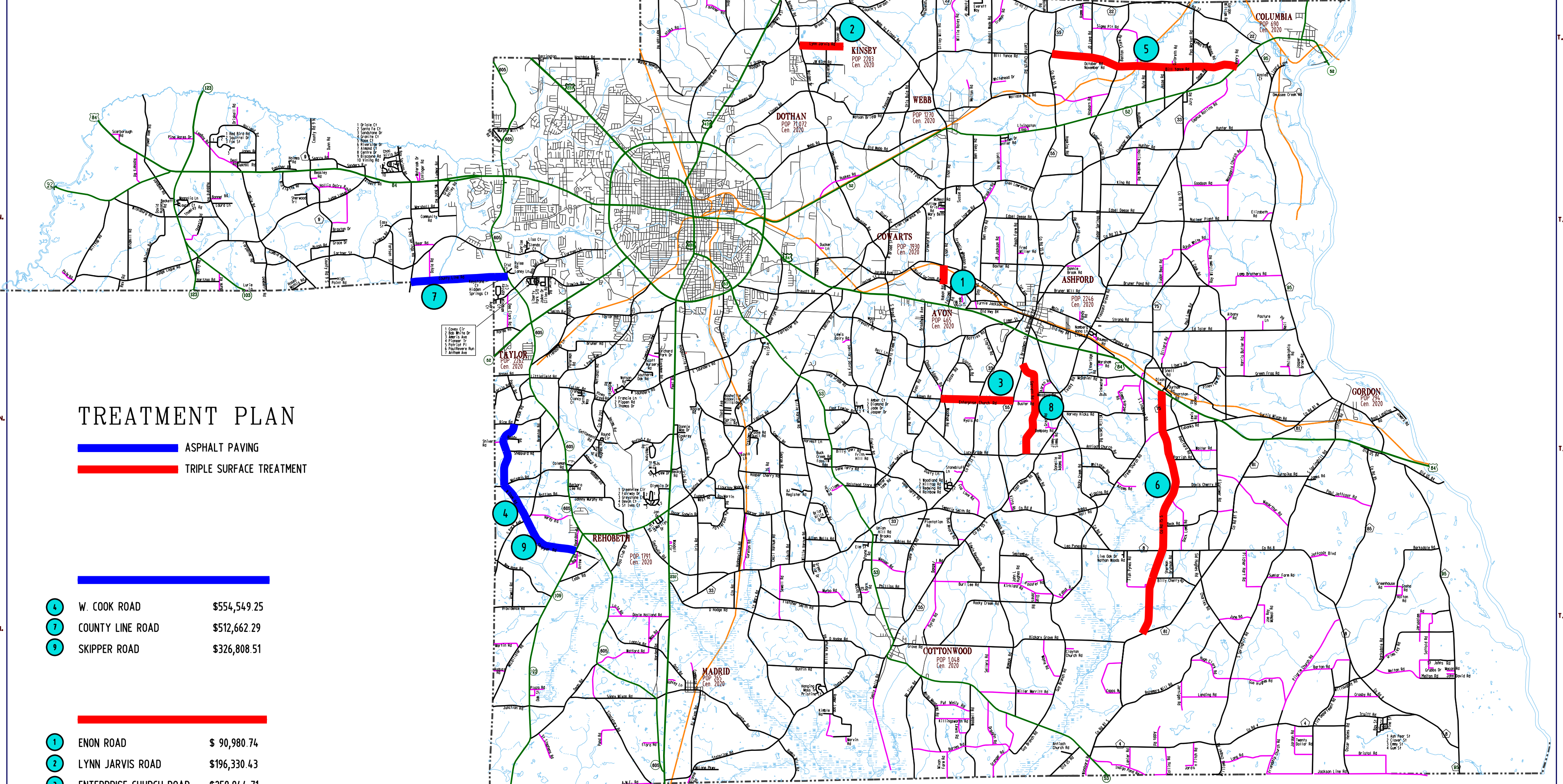
Any remaining CRAF balance and FAEF money will be carried over for future projects.

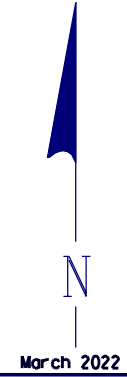
