It is recommended that **NOVITA WATER CONDITIONER** be used wherever a pest control product recommends the use of ammonium sulfate or where hard water is a concern for active ingredient performance. **NOVITA WATER CONDITIONER** may be used with all pesticide types when acidic conditions are acceptable. **NOVITA WATER CONDITIONER** is highly recommended when using acid or acid salt forms of pesticidal ingredients.

DIRECTIONS FOR USE

NOVITA WATER CONDITIONER does not contain oil or surfactant but may be used in conjunction with these products. Use only with pesticides that allow low pH conditions. Do not use with copper-containing actives.

Follow the mixing procedure for the pesticide being used. While **NOVITA WATER CONDITIONER** may be added at any time, it should be added after any wettable powders or other solid formulations have been thoroughly dispersed, for maximum efficacy.
