Cimline, Inc. is bidding 3 sizes of trailer mounted crack sealers, and 2 sizes of mastic patchers all trailer mounted. Cimline is bidding the multiple units rather than the combination machine due to ease of use and simplified access to pre-packaged materials in the marketplace. This is the most common representation of the industry usage today on the State, County, and Municipal level. Cimline believes it continues to meet the intent of the bid program and repair methods.

Deviations:

- Heated Mixing Chamber The ME machines only continue to have a heated mixing chamber for mastic material with aggregate
- Local Crushed Aggregate The pre-packaged material offers the correct clean and washed aggregate with the binder in a simpler form to use for the agency
- Receiving Hopper A receiving hopper is no longer needed with pre-packaged material. Insulated loading doors meeting the bid requirement are standard equipment.
- Positive Displacement Pump for Mastic Material Flow With pre-packaged material the correct amount of binder and aggregate are included in each box. The melter will continue to have sealant flow, but the Mastic mixer will be mixed all in one kettle.
- Two Self-Igniting Burners Each trailer mounted machine now only requires 1 self-igniting burner for production capacity. Each burner is sized properly for the size of kettle.
- Aggregate Hopper Aggregate Hopper is not required. Pre-packaged material is loaded directly into kettle in a properly sized meltable package.
- Aggregate lifting system for mixing This is no longer required with the pre-packaged material.
- Mastic Placement Trough For ease of use of use is heated by propane with the hand tools not electrically heated.

GENERAL

These specifications shall be construed as the minimum acceptable standards for a Trailer-mounted Mastic patcher and crack sealer. Should the manufacturer's current published data or specifications exceed these standards, the manufacturer's standards shall be considered minimum and shall be furnished. All integral parts not specifically mentioned in the scope of these specifications that are necessary to provide a complete working unit shall be furnished. Additionally, the machine for bid offered shall include all standard manufacturers' equipment. The trailer mounted mastic patcher and crack sealer must be a new current production model and shall meet all EPA applicable standards at the time of manufacture.

The use of specific names and numbers in the specification is not intended to restrict the bidder or any seller or manufacturer, but is intended solely for the purpose of indicating the type, size and quality of equipment considered best adapted to the uses of counties participating in this joint bid.

The combination crack sealing unit and mastic mixer must be able to safely melt, agitate, circulate and apply all grades of asphalt rubber sealants, specification joint sealants, jet fuel resistant sealants and fiber modified asphalt sealants. The machine must be capable of starting at ambient temperature and bringing material to pouring temperature in less than one hour. The unit must have continuous sealant agitation with internal recirculation of sealant (not hose recirculation) to eliminate temperature stratification of sealant being applied. This unit must also be capable of handling and heating local crushed aggregate and mixing it with sealants on board. The unit must be able to change ratio of sealant to aggregate on demand. The unit must be able to heat the aggregate to eliminate any moisture that will contaminate the the mixed mastic material. Mastic mix to be delivered by heated placement trough. Complete operation manual and parts list must be furnished with the unit. A factory-trained representative will be available for initial startup and training. 1.2 The equipment being bid must be new, current year production and meet the needs of this specification without modification. The model must have a working volume of not less than 150 gallons called for in this specification. Hybrid, one-off or prototype equipment is unacceptable.

Except as provided herein, no agent, dealer, employee or any other person is authorized to give any warranties of any nature outside of this agreement on behalf of Cimline, inc.

Cimline Equipment is warranted for two years / 2000 hours of use and includes/excludes the following:

Includes; basic frame and tanks, steel fabricated parts, hydraulic and burner control system.

Excludes; the engine, air compressor, battery, and tires as these items are covered by their respective manufacturer and all warranty for these items should be directed to their local authorized distributor/dealer.

Warranty period; begins at the date unit is first placed in service, or shipped from the factory. Upon sale or rental of the equipment by the distributor or Cimline, the provided warranty card should be mailed within 14 days stating date the unit is placed in service thus beginning the warranty period.

In the absence of any warranty card on file, the warranty period begins from date of shipment from factory.

Warranty for material pumps, electric heated hoses or heated hose with heated wands, are pro-rated using the following scale:

Any warranty claims on parts may require a return for evaluation. Specifically, heated wands with heated hose, standard heated hoses, and material pumps will require an appropriate Return Merchandise Authorization (RMA) from Cimline Customer Care and that the item be returned for evaluation with that RMA for any warranty claim to be considered. For electric heated hose with heated wand claims; the defective hose and wand must be returned as a pair to the Cimline factory for Inspection, unless the heated wand has a serial number on the handle, than It can ship back alone. All other components must be returned only at the request of Cimline Customer Service.

Replacement parts are warranted for a period of 60 days from factory invoice, with the exception of the replacement material pumps, heated hoses and heated hoses with heated wands, which use the above scale for pro-rated coverage. For replacement parts that are purchased from distributor stock, the 60-day period will commence from the date of distributor to end user invoice. A copy of the invoice will be required as proof of in service date. If invoice is not provided, policy will revert back to the original factory invoice date.

Warranty does not apply to defects caused by improper or unreasonable use, including but not limited to damage (including freight damage), accidents, failure to provide reasonable maintenance, labor or supplies related to cleaning of unit with excessive material unless that material was caused by a warranty issue, or faulty repair made by others. Furthermore, warranty is void if the product or any of its components are modified or altered in any way or if aftermarket (NON-OEM) parts have been used during the warranty period. In the event of freight damage, a claim must be filed by the purchaser with the freight carrier.

Our responsibility under this warranty is limited to replacement or repair (at Cimline's discretion) of such part or parts, as inspection shall disclose to have been defective, to be performed at Cimline Inc. factory at Plymouth, MN or at a facility designated by Cimline.

In no event shall Cimline Pavement Maintenance Group be liable for incidental or consequential damages of any kind whatsoever. Downtime, overhead and performance penalties are not recognized at any time as part of warranty coverage. Reasonable labor, travel, and diagnostic time will be reviewed for reimbursement. The use of aftermarket (NON-OEM) parts will result in denial of the claim. Mileage will be reimbursed at a rate of \$0.80 (80 cents) per mile (domestic 48 states), and no more than one round trip per claim, or more than 500 total miles in distance. Shop Labor will be reimbursed at a max rate of \$80/hour. Parts freight will be reimbursed at a "UPS REGULAR" rate only for stock items, and for non-stock items will be reimbursed at a "UPS BLUE" rate.

All warranty claims must be processed through the factory authorized Cimline dealer that was the original distributor of your Cimline Equipment or OEM Parts. All claim notices to Cimline pursuant to this limited warranty must be made by completing a Cimline Warranty Claim Form which should be Emailed to: customercareorders@plymouthind.com

No exceptions will be made to this warranty unless agreed to in writing by the Cimline Director.

This warranty is in lieu of all other warranties expressed or implied, and such other warranties are hereby disclaimed including any warranty of merchantability and fitness for a particular purpose.



NOTICE OF BID OPENING PROCEDURES

All bids for **Heavy Equipment** will be opened and the name(s) of the bidders read aloud on the morning of the bid opening on **Friday, November 1, 2024 at 10:00 a.m.** at 2 North Jackson Street, Montgomery, AL. The specifics of each bid submitted will be compiled by the Association staff thereafter and will be available, **upon written or emailed request**, one week after the bid opening. Requests should be emailed to jointbid@alabamacounties.org.

THE INVITATION PACKAGE

The invitation package for each item to be bid includes: this invitation to bid, the written bid specifications for the particular item of heavy road equipment, and a Bid Submittal Form to be used in submitting a bid for that particular item. Bidders should verify that they have received all pages of the invitation package. If there are any omissions, the bidder should contact **Kenya Howard** in the Association office by mail, fax, or e-mail (jointbid@alabamacounties.org) to request missing pages. It is the responsibility of the bidder to make this request in sufficient time to prepare and submit the bid in time for the bid opening. Bidders should carefully read and comply with all parts of the invitation package, including all attachments and/or any addendum.

PREPARING AND SUBMITTING BIDS

All bids must be typed or hand written in ink on the attached Bid Submittal Form. The completed Bid Submittal Form shall be placed in front of and separated from all other documents included in the bid packet, such that it will be the first document viewed upon opening the bid packet.

Bids submitted in pencil and bids not submitted on the Bid Submittal Form *will not* be considered. BID SPECIFICATIONS

Please note that each piece of heavy equipment available for bid may include several different sizes and categories of machines. You should read each set of specifications very carefully as the differences vary depending upon the piece and size of equipment.

The award will be based on the total cost of the **Standard Machine** bid by the lowest responsible bidder. Each Bid shall include a **Manufacturer's Suggested Retail Price Sheet (MSRP)** for each machine bid. The percent difference between the Manufacturer's Suggested Retail Price (MSRP) for the standard machine as specified by these bid specifications and the actual price bid by the vendor will be calculated and that percentage discount shall be applied to any options an individual county may choose to add to the machine.
