Description of Work: Pave meaning is Scrub Seal and/or Microsurface. Stripe meaning Temporary Paint and Permanent Stripe being Thin lay Thermoplastic or Paint. All required Marking & Legends included in project. Base patching and Leveling may be required at time of Construction.
