Sumter County is taking sealed bids for labor, equipment, materials, and any incidentals required to complete the work required for the BASE PROJECT: RESURFACING AND TRAFFIC STRIPE ON CARL TURK CR-12 FROM AL HWY 17 EASTWARDLY APPROXIMATELY 8.2 MILES TO US HWY 11; and the ALTERNATE ADDITIVE PROJECT: RESURFACING AND TRAFFIC STRIPE ON PAYNEVILLE CR-12 FROM MS. STATE LINE EASTWARDLY APPROXIMATELY 5.1 MILES TO AL HWY 17 (SUMTER COUNTY PROJECT RA-SCP 01-01-2025). This bid is intended to comply with the Rebuild Alabama Act, No. 2019-2, and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be marked with the word “**BID**” on the outside of the bid package along with **Bid Proposal for the BASE PROJECT: RESURFACING AND TRAFFIC STRIPE ON CARL TURK CR-12 FROM AL HWY 17 EASTWARDLY APPROXIMATELY 8.2 MILES TO US HWY 11; and the ALTERNATE ADDITIVE PROJECT: RESURFACING AND TRAFFIC STRIPE ON PAYNEVILLE CR-12 FROM MS. STATE LINE EASTWARDLY APPROXIMATELY 5.1 MILES TO AL HWY 17 (SUMTER COUNTY PROJECT RA-SCP 01-01-2025), the bid date and the Alabama General Contractor’s License Number.**

The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U. S. Government, the State of Alabama, any relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act.

Sealed bids will be received by the Sumter County Commission at the Sumter County Commission Courthouse Annex, P.O. Box 70, 104 Hospital Drive, Livingston, Alabama 35470, until **10:00 AM Central Time on Wednesday, June 4, 2025** and then publicly opened as soon thereafter as practicable. Award will be made at the next regularly scheduled meeting of the Sumter County Commission.

This project will be eligible for a Certificate of Exemption as provided by ACT 2021-372. Once the low bidder is determined, the County will request a copy of the Form ST-EXC 1 prior to the award of the bid to the lowest responsible bidder. The contractor shall provide the County with the Form ST-EXC 1 within 48 hours of the County’s request.
