



## ADVERTISEMENT FOR BIDS Marshall County

Marshall County is taking sealed bids for labor, equipment, materials, and any incidentals required to complete the work required for the following inquiries of the County:

## BRIDGE REPLACEMENT ON THOMAS LANE (NKA DUNCAN FARM ROAD) OVER PARKELL CREEK (MCP 48-104-24)

These bids are intended to comply with the Rebuild Alabama Act, No 2019-2, and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.

Bids must be submitted on proposal forms furnished by the Owner. All bidders must show evidence of license before bidding or bid will not be received or considered by the owner; the bidder shall show such evidence by clearly displaying his or her current license number on the outside of the envelope in which the proposal is delivered. The Owner reserves the right to reject any or all proposals and to waive technical errors if, in the Owner's judgment, the best interests of the Owner will thereby be promoted. No bid may be withdrawn after the scheduled closing time for receipt of bids for a period of thirty (30) days.

A certified check or bank draft, payable to Marshall County Commission, or a satisfactory bid bond executed by the bidder and acceptable sureties in an amount equal to five (5) percent of the bid, but not to exceed \$10,000.00 shall be submitted with each bid.

The successful bidder will be required to furnish and pay for satisfactory performance and payment bonds, each in the amount of 100% of the contract price.

Contractor shall be licensed in accordance with the State Laws. Proof of licensure will be required on the outside of the Bid Envelope before bid will be considered. Subcontractors whose contracts exceed \$50,000.00 must also be licensed according to the State of Alabama Law and show proof thereof.

Sealed bids will be received by the Marshall County Engineer's Office at the Marshall County Courthouse, 424 Blount Avenue, Suite A337 or by mail to 424 Blount Avenue, Suite 305, Guntersville, AL 35976, until 2:00 PM Central Time on Tuesday, July 15, 2025, and then publicly opened and read aloud as soon thereafter as practicable. Award will be made at the next regularly scheduled meeting of the Marshall County Commission.

## Each bidder is required to submit with the bid a certificate of E-Verify.
