The Coffee County Commission will open sealed bids in the Office Complex, 1065 East McKinnon Street, New Brockton, Alabama at the time specified above.

All bidders must use our bid form and must show the opening date on the face of your company's envelope containing the bid. Failure to comply with this may result in your bid not being considered.

Each bid must be filled out in ink and notarized. Coffee County reserves the right to accept or reject any or all bids or portions thereof. No errors will be corrected after the bids are opened. No prices will include State or Federal Excise taxes. Tax exemption certificates will be furnished upon request.

ACCEPTANCE OR REJECTION OF PROPOSALS: The Coffee County Commission reserves the right to reject any or all proposals. Without limiting the generality or the foregoing; any proposal having erasures or corrections in the price sheet may be rejected; any proposal which omits a bid or any one or more items in the price sheet may be rejected; any proposal in which prices are omitted, or in which prices are obviously unbalanced may be rejected.

A bid bond is not required for this bid.

SPECIFICATIONS

The following bid items shall be in accordance with the appropriate sections of the latest edition of the State of Alabama Department of Transportation Standard Specifications for Highway Construction. The use of specific names or numbers in the specifications is not intended to restrict the bidder or any seller or supplier but is intended solely for the purpose of indicating the type and quality of material considered best adapted to the use of Coffee County. Upon request, test reports shall be submitted on all materials before payment will be made. Price(s) shall reflect the pickup of materials as detailed below.

All limestone and granite aggregates shall meet or exceed specifications as outlined within, and shall comply with each of the following:

Option A: Standard ALDOT material for general construction purpose use

All materials shall meet the most recent applicable section of the Alabama Department of Transportation Specifications for Limestone and Granite Aggregates and/or be approved by the purchasing County Engineer.

Option B: Washed Aggregate as specified for Bituminous Surface Treatment Application

Coarse Aggregate specified for Bituminous Surface Treatment applications shall be washed and shall be free from adherent coatings. All materials shall comply with the requirements of Section 801 of the most recent edition of the Alabama Department of Transportation Standard Specifications for Highway Construction.

Each bidder shall provide, with each product bid, one (1) copy of the producer's published specifications/technical data and any certifications required within these specifications.

Representative must be available to assist County in handling of complaints, if necessary.

Bidders are not required to bid on all items. However, bidders are encouraged to bid on both limestone and granite aggregates if available.

Each item will be awarded separately, for limestone and granite. The requested aggregates shall be available within two (2) business days of purchase order from the County Engineer, unless a time extension is given by the County Engineer.

The bidder shall indicate the plant name, physical address, and contact person, phone number, and email address for Coffee County to use for the issuance of purchase orders.

The bid prices will be in effect from January 1, 2026 through December 31, 2026.

This bid will establish an annual contract for the calendar year 2026 that will automatically renew at the end of each calendar year under the same pricing, terms, and conditions for up to three years unless notification is received in writing by certified mail from the vendor at least sixty (60) days prior to the expiration of the current year term. The second and third contract would begin the day after the first- or second-year contract expires. Coffee County reserves the right to reject any and all bids.

This bid is to furnish and load crushed granite onto County provided transportation. Bid price is FOB. your plant. A major factor in awarding the bid will be the hauling distance to New Brockton, Alabama. Coffee County may not use the low bid.
