These bids are intended to comply with the Rebuild Alabama Act, No. 2019-2, Alabama Code Title 39, the Alabama Public Works Law, and/or Alabama Code Title 41, the Alabama Competitive Bid Law. Bidders shall be required to comply with afore mentioned provisions regardless of whether the requirements are explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be sealed and marked as instructed in the bid request packet.

The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U. S. Government, the State of Alabama, any relevant municipality, and Franklin County. The contractor shall specifically, and without limitation, comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act. Alabama Code Section 39-3-5, resident contractor preference, applies. Prequalification will not be required for this bid.

Sealed bids will be received by the Franklin County Commission at 405 N Jackson Ave. Russellville, AL 35653 until 2:00 PM Central Time on Wednesday, November 19, 2025, and then publicly opened as soon thereafter as practicable. The award will be held at a regularly scheduled meeting of the Franklin County Commission.
