



NOTICE TO CONTRACTORS ANNUAL BITUMINOUS SURFACE TREATMENT COFFEE COUNTY, ALABAMA

Sealed bids will be received by the Coffee County Commission at the Office Complex in New Brockton, Alabama, until 9:00 A.M., December 17, 2025, and at that time publicly open for constructing the following:

Annual bid for supplying and placement of Bituminous Surface Treatments in quantities as requested by the Coffee County Highway Department.

The contract period shall be for 12-months with an option to issue a second and third 12-month contract under the same pricing, terms and conditions.

A certified check or bid bond payable to the Coffee County Commission for an amount of 5% of bid (maximum - \$10,000) must accompany each bid as evidence of good faith.

Specifications and Proposals may be obtained at the Coffee County Engineer's Office, 1165 East McKinnon Street, New Brockton, Alabama from 6:30 A.M. until 5:00 P.M., Monday through Thursday (telephone 334-894-6112). No proposal fee is required.

The bidder's proposal must be submitted on the complete original proposal furnished him by the Coffee County Commission. Bids will be received only from contractors duly licensed by the State Licensing Board for General Contractors.

This project will be eligible for a Certificate of Exemption as provided by Act 2021-372. Once a proceed order is issued, the contractor shall have 5 days to submit the Form ST-EXC 1 to the County.

The right to reject any or all bids is reserved.

The Coffee County Commission will open sealed bids in the Office Complex, US84, New Brockton, Alabama at the time specified above.

All bidders must use our bid form and must show the opening date on the face of your company's envelope containing the bid. Failure to comply with this may result in your bid not being considered.

Each bid must be filled out in ink and notarized. Coffee County reserves the right to accept or reject any or all bids or portions thereof. No errors will be corrected after the bids are opened. No prices will include State or Federal Excise taxes. Tax exemption certificates will be furnished upon request.

ACCEPTANCE OR REJECTION OF PROPOSALS: The Coffee County Commission reserves the right to reject any or all proposals. Without limiting the generality or the foregoing; any proposal having erasures or corrections in the price sheet may be rejected; any proposal which omits a bid or any one or more items in the price sheet may be rejected; any proposal in which prices are omitted, or in which prices are obviously unbalanced may be rejected; and any proposal accompanied by an insufficient or irregular bid bond may be rejected.

The bidder must submit a cashier's check or bid bond for five percent (5%) of the bid amount (maximum bond amount \$10,000) along with his bid. This check or bid bond must be made payable to COFFEE COUNTY COMMISSION, and be certified by a reputable banking institution or bonding company. Checks of unsuccessful bidders will be returned promptly. Checks of the successful bid shall be returned after fulfilling the bid. Upon award bidder shall furnish contract bonds in accordance with Alabama Public Works Laws.

Contractors must be in compliance with EEO Laws, the Copeland "Anti-Kickback" Act, and the Contract Work Hours and Safety Standards Act.

ALL BIDDERS MUST USE OUR BID FORM AND PROPERLY IDENTIFY ON THE OUTSIDE OF THE ENVELOPE THE DATE AND TIME OF BID OPENING.

SPECIFICATIONS

For Bid No. 2026-15

Annual Bituminous Surface Treatments

GENERAL: The bidder shall furnish all necessary materials, labor, machinery, tools, apparatus and other means of construction for the placement of Bituminous Surface Treatments in quantities and locations as requested by the Coffee County Highway Department.

PERIOD: This bid is to establish a twelve (12) month contract with an option to issue a second and third twelve (12) month contract under the same pricing, terms and conditions. The second or third contract, if requested by the County and agreed upon by the vendor, would begin the day after the first or second contract expires. Any successive contract must have written approval of both the County and the Vendor no later than thirty (30) days prior to the expiration of the previous contract.

The first contract period shall expire on December 31, 2026.

TERMS: The bidder is to place Bituminous Treatments in quantities as requested by the Coffee County Highway Department through December 31, 2026. Work to be in compliance with Sections 401 and 409 of the current Alabama Department of Transportation Standard Specifications for Highway Construction. Bituminous price adjustments apply to this bid in accordance with ALDOT Standard Specifications, the base index month for this bid shall be December 2025.

The Bituminous Surface Treatments shall be composed of granite in all layers. Surfaces with any carbonate stone layers shall not be included in this bid.

The bidder is to place the materials in a manner conforming to the Alabama Department of Transportation Standard Specifications for Highway Construction, latest edition. Payment for bidder's work shall be as specified by the Alabama Department of Transportation Standard Specifications for Highway Construction, latest edition.

The total square yards per work order shall be used to determine the unit price. A work order may be issued for a single Coffee County road or there may be multiple Coffee County roads per work order.

The contractor shall furnish flagmen, pilot car and portable traffic control devices in accordance with the Manual of Uniform Traffic Control Devices, Latest Edition. Cost of furnishing traffic control devices shall be considered a subsidiary obligation of the work.

This project will be eligible for a Certificate of Exemption as provided by Act 2021-372. Once a proceed order is issued, the contractor shall have 5 days to submit the Form ST-EXC 1 to the County.

All Companies submitting bids must have an Alabama State General Contractor's License. A copy of the license shall be submitted with this bid.

All bidders must use the attached bid form and must show the opening date and time on the face of the envelope containing the bid. Failure to comply with this may result in your bid not being considered.

Each bid must be filled out in ink and notarized. The Coffee County Commission reserves the right to accept or reject any or all parts of bids.

The bidder shall enclose a certified check or bid bond for five percent (5%) of bid (maximum - \$10,000.00) and hereby agrees that in case of failure to execute contract and furnish contract bonds as required by The Code of Alabama 1975 within fifteen (15) days after notice of award, the awarding authority shall recover from the principal or the sureties if the guaranty to be a bid bond, the difference between the amount of the contract as awarded and the amount of the proposal of the next lowest bidder. If no other bids are received, the full amount of the proposal guaranty shall be so retained or recovered as Liquidated Damages for such default. It is understood that in case the work is not awarded to the undersigned, the check will be returned as provided in the Alabama Department of Transportation Standard Specification, current edition.

THE FOLLOWING ITEMS SHALL BE IN ACCORDANCE WITH THE ALABAMA DEPARTMENT OF TRANSPORTATION STANDARD SPECIFICATIONS, CURRENT EDITION, EXCEPT AS MODIFIED BY APPLICABLE SPECIAL PROVISIONS.
