Bidders shall also be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Ala. Code, as amended, regardless of whether or not the requirements are explicitly detailed in the bid proposal.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted.

Bidders shall meet all ALDOT Bonding and Licensing requirements as well as all

Ala. Code § 39-3-5 (1975): Section 39-3-5 provides for a preference to resident contractors in the letting of certain public contracts. In the letting of public contracts in which any state, county, or municipal funds are utilized, except those contracts funded in whole or in part with funds received from a federal agency, preference shall be given to resident contractors, and a nonresident bidder domiciled in a state having laws granting preference to local contractors shall be awarded Alabama public contracts only on the same basis as the nonresident bidder's state awards contracts to Alabama contractors bidding under similar circumstances; and resident contractors in Alabama, as defined in Section 39-2-12, be they corporate, individuals, or partnerships, are to be granted preference over nonresidents in awarding contracts in the same manner and to the same extent as provided by the laws of the state of domicile of the nonresident.
