### S P E C I F I C A T I O N S

The following bid items shall be in accordance with the latest edition of the State of Alabama Department of Transportation Specifications.

The bid prices will be in effect through December 31, 2026. All items will be awarded separately.

#### CONTRACT PERIOD

Establish an annual contract for the calendar year 2026 that will automatically renew at the end of each calendar year under the same pricing, terms, and conditions for up to three years unless notification is received in writing by certified mail from the vendor at least sixty (60) days prior to the expiration of the current year term. The second and third contract, would begin the day after the first- or second-year contract expires. Coffee County reserves the right to reject any and all bids.

This bid is to furnish and load crushed granite onto County provided transportation. Bid price is F. O. B. your plant. A major factor in awarding the bid will be the hauling distance to New Brockton, Alabama. Coffee County may not use the low bid.
