Talladega County is taking sealed bids for its FY 2026 annual work program. Bids are requested for labor, equipment, materials, and any incidentals required to complete the work required in the following individual bid request:

- **TC PWB 2026-2: Annual Paving with Bituminous Concrete Asphalt (Plant Mix) Bid**

These bids are intended to comply with the Rebuild Alabama Act, No. 2019-2, and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be sealed and marked as called for in the bid request packet

The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U. S. Government, the State of Alabama, any relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act. Alabama Code Section 39-3-5, resident contractor preference, applies. Prequalification will not be required for this bid. The awarded contracts be eligible for a Certificate of Exemption as provided by Act 2021-372.

Talladega County is taking bids for labor, equipment, materials, and any incidentals required to complete the work of the following items required for the Annual Paving with Bituminous Concrete Asphalt (Plant Mix) for Talladega County. This bid is intended to comply with the Rebuild Alabama Act, No. 2019-2, and Alabama Code Title 39, the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not. This bid shall be in effect from 2/24/2026 until 2/23/2027 covering any Proceed Orders issued by Talladega County during that time frame.

Sealed bids will be received by the Talladega County Commission at the Commission Office until 1:00 PM Central Time on Tuesday, February 17, 2026 and then publicly opened in the Talladega County Commission meeting room at 1:00 pm on Wednesday February 18, 2026. Award will be made at the next regularly scheduled meeting of the Talladega County Commission on Monday February 23, 2026. Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted. All bids must be marked with the word "BID" on the outside of the bid package along with Bid Proposal for Annual Paving with Bituminous Concrete Asphalt (Plant Mix), the bid date and the Alabama General Contractor's License Number.

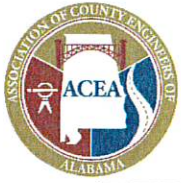
The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and Licensing requirements as well as all applicable laws, ordinances, and codes of the U. S. Government, the State of Alabama, any relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act.

All bid items shall be placed in accordance with the bid items and specifications, current revision of the Alabama Department of Transportation Standard Specifications (non-metric edition), and any Supplemental Specifications approved by the Talladega County Engineer. This project is being advertised, let to contract, and administered by an awarding authority other than the Alabama Department of Transportation (ALDOT). All references made in the standard specifications and in other related and included documents of this proposal, to ALDOT (except as applies to references made to ALDOT considering a bidder to be disqualified from bidding, or to the awarding authority consulting or interacting with ALDOT, etc.), the "State", the "Department" or "Highway Department", etc. shall be understood to mean the awarding authority for this project.

Should the bidder desire to offer a substitute for any item listed in this proposal, a full description of the item(s) offered as substitutes shall be submitted to the County Engineer at least 48 hours before the time stated for opening the bids. The County Engineer will issue an addendum, if necessary, to all bidders who have obtained a bid proposal. Each bidder shall include a copy of the addendum with his/her signature indicating they had received the addendum when submitting their bid. If no addendum is issued, the substitute will not be considered in determining the lowest responsible bidder. No bid proposals or additional addenda will be issued 24 hours prior to the time of the bid opening.

Signature on bid must be in ink. Bids made out in pencil will NOT be accepted. Talladega County reserves the right to accept or reject all Bids or any portion thereof. BID PROPOSAL FOR **(PWB 2026-2 ANNUAL PAVING WITH BITUMINOUS CONCRETE ASPHALT** **(PLANT MIX)**

To the Talladega County Commission:

The undersigned shall give Talladega County at least 48 hours' notice in advance of performing work at any site once a Proceed Order has been issued by Talladega County. The undersigned must receive written permission to work on Saturdays, Sundays, or County recognized holidays 48 hours prior to such work commencing. Unless otherwise directed in writing by the County Engineer, the undersigned will be expected to begin work within 15 calendar days after issuance of the Proceed Order. The undersigned will be given a minimum of Thirty (30) Working Days as defined in the current revision of the Alabama Department of Transportation Standard Specifications, per Proceed Order. Each Proceed Order shall designate the number of working days or calendar days allowed. Should the undersigned fail to complete the project or projects specified in the Proceed Order within the working days or calendar days stipulated, liquidated damages shall be assessed as defined in section 108.10 in the current revision of the Alabama Department of Transportation Standard Specifications or as amended by Special Provision.

Any bid accepted by Talladega County shall be valid for any other governmental agency within Talladega County; any such governmental agency may contract with the entity whose bid is accepted at the bid price(s) accepted by Talladega County and any successful bidder shall be required to perform the work for which the bid was provided at the bid price described in the bid documents for any other governmental agency in Talladega County pursuant to the terms and conditions of said bid documents.

A certified check, drawn on an Alabama Bank, or bid bond, for \$10,000 made payable to the Talladega County Commission is enclosed as evidence of good faith. Within 15 days upon notification of bid award, the undersigned shall submit a Performance Bond for \$1,000,000 and a Payment Bond for \$500,000 to Talladega County along with the contract documents, certificate of public liability insurance, certificate of proof of workman's compensation insurance, and business license. The undersigned shall provide to the County his/her Alabama Department of Transportation (ALDOT) Vendor Identification Number as shown on the E-Verify Compliance Status List on the ALDOT website as proof of enrollment in E-Verify.

The undersigned shall submit the Advertisement of Project Completion to Talladega County immediately following the completion and acceptance of all work required, per Proceed Order. The County Engineer will submit the advertisement to the Association of County Commissions of Alabama (ACCA) to be posted on a website maintained by ACCA for a period of four consecutive weeks.

The undersigned shall give notice of the project completion by advertising for four consecutive weeks in a newspaper of general circulation published within the city of county where the work has been performed.

Upon completion and acceptance of all work required, the undersigned will be paid upon presentation of the following:

- a. A properly executed and duly certified voucher for final payment.
- b. A release of all claims and claims of liens against the awarding authority arising by virtue of the contract.

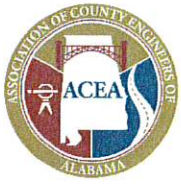


c. Proof of Advertisement of project completion (AL Code 39-1-1(f) requires a 30 day waiting period after the notice has run before final settlement can be made).

The undersigned agrees: Final payment will be made within 35 days after all the above requirements are met; Partial Payments, to be paid no more than once monthly, for each Proceed Order will be provided under this contract; Retainage shall be withheld on each Proceed Order as required under Code of Alabama Section 39-2-12.

By submitting this proposal, the contracting parties affirm, for the duration of the agreement, that they will not violate the federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the State of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.

INSURANCE REQUIREMENTS

The Contractor, at its sole expense, shall obtain and maintain in full force the following insurance to protect the Contractor and the County Commission of Talladega County, Alabama (CCTC) at limits and coverages specified below. These limits and coverages specified are the minimum to be maintained and are not intended to represent the correct insurance needed to fully and adequately protect the Contractor.

All insurance will be provided by insurers licensed to conduct business in the State of Alabama and shall have a minimum A.M. Best rating of A- VII and must be acceptable to the CCTC. Self-insured plans and/or group funds not having an A.M. Best rating must be submitted to the CCTC for prior approval.

No work shall be performed until proof of compliance with the insurance requirements has been received by the CTCC.

The Additional Insured form MUST include the current Operations and Products/Completed Operations of the contractor. The naming of the additional insured does not obligate the additional insured to pay any premiums due.

- Aggregate limits to be on a "per project" basis OR an Owners and Contractors Protective Liability Policy shall be provided in the name of CCTC, the contractor and Subcontractors. Limits to be the same as above Commercial General Liability.

(c) **Automobile Liability**

Covering all Owned, Non-Owned, and Hired vehicles with a Combined single limit (bodily injury and property damage combined) of \$3,000,000 each accident. The policy shall name CCTC its officers, appointees, employees, and agents as an Additional Insured.

(d) **Protection and Indemnity Insurance**

If the contract involves work aboard an Owned, Non-Owned or Hired Vessel, Liability coverage in the amount of \$3,000,000 per occurrence shall be maintained.

(d) **Indemnification and Liability**

Under this section the term County shall include Talladega County, the Talladega County Commission, the officers, appointees, department heads, agents, and employees of the Talladega County Commission.

The County shall not be liable for any injury to the person or property of any person, firm, or corporation resulting directly or indirectly from Contractor's performance of this Contract, and the Contractor assumes full and complete responsibility therefore.

The Contractor shall further indemnify the County and hold the County safe and harmless from any and all liability, lawsuits, judgments, attorney fees, and other costs incurred by the County in defending any claim or lawsuit made against the County by any person, firm, or corporation arising directly or indirectly out of any work performed by the Contractor pursuant hereto or any breach or alleged breach of duty or responsibility of the Contractor related thereto.

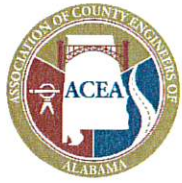
Waiver of Subrogation

The Workers Compensation Policy shall contain a Waiver of Subrogation in favor of the CCTC, its officers, appointees, employees, and agents.

Certificate of Insurance

A Certificate of Insurance evidencing the above minimum requirements must be provided to and accepted by the CCTC PRIOR to commencement of any work on the contract. Each policy shall be endorsed by the issuing insurer to provide thirty (30) days prior written notice of cancellation to the CCTC.

The unit prices below will apply to each Proceed Order issued and should be based on County Wide Pricing. A Proceed Order may include multiple projects or sites. Each Proceed Order shall note the items required and estimated quantities per project or site.

PRICE ADJUSTMENTS will be made to all Asphalt Materials in accordance with the following: It is understood and agreed that the price per Ton of materials bid is based on prices at the time of opening of bids. Prices on contracts developed from this bid will be adjusted based on the PRICE INDEX per gallon of asphalt as determined by the ALDOT Asphalt Index for the month of December 2025. Any increase or decrease in asphalt prices will be determined and adjusted by the price index for the month in which delivery and placement is made. Adjustment will be made in accordance with the current ALDOT Specifications. This adjustment shall apply to the amount of tack and prime used and the amount of liquid used in the plant mix material.

Please note that for pay item 408A-052 Talladega County will retain the millings. Talladega County will provide a location to haul the millings within a 20-mile radius of any project or site location.

Upon request, Test Reports shall be submitted on all materials before Payment will be made. The Contractor shall furnish flagmen and portable traffic control devices (or other method approved by the County Engineer) in accordance with current revision of the Manual of Uniform Traffic Control Devices (MUTCD). Item 405-A Tack Coat shall be included in the bid price per ton for all applicable items below. The Talladega County Engineer shall serve as the final authority for all phases of workmanship and materials.

BALANCED MIX DESIGN ASPHALT SPECIFICATIONS

Materials to be in compliance with Section 424 of the State of Alabama Highway Department Standard specifications for Highways and Bridges, 2022 Edition, with the exception that production mix volumetric testing/frequencies using NDES samples are to be replaced with mix performance testing/frequencies using height compacted samples. ASTM D8225 (replacing the word "deformation" with "displacement" in Section 6.1.1) will be run at 77F to ensure average CT index values equal or exceed 50 with a target of 75 at intermediate temperature to prevent cracking. Testing will be repeated at 122F on identically prepared samples to ensure average indirect tensile strength at high temperature equals or exceeds 17 with a target of 20 psi to prevent rutting. Mix proportions necessary to satisfy performance results will be established via test strip. Mix performance testing will be run within the first 100 tons of shipped mix each day, and testing will be repeated if mix is still being shipped after 5 hours and the total shipped tonnage for the day exceeds 500. Failing results will necessitate resting. A second set of failing results will necessitate a new strip to reestablish mix proportions. All mixes (regardless of maximum aggregate size and placement layer) can contain up to 35 percent reclaimed and recycled material and specified virgin aggregate properties (with the exception of minimum bulk specific gravity, absorption, deleterious materials, LA abrasion, and carbonate stone limitations for coarse aggregates and minimum

bulk specific gravity and sand equivalency for fine aggregates) may be waived provided all stockpiles meet the requirements of ALDOT-249 and mix performance testing results exceed minimum values. In no case can recycled shingles be used in the mix. Price to include all materials, labor, and equipment required to haul, spread, clean roadway and compact the asphalt material in place in compliance with applicable sections of the specifications.

If average CT index values fall below 38 the potential cracking will be considered too great and may be subject to removal and replacement.
