

BID SPECIFICATIONS FOR 16' STEEL DUMP BODY F (AUTOMATIC TRANSMISSION)

GENERAL

These specifications shall be construed as the minimum acceptable standards for a 16' Steel Dump Body. Should the manufacturer's current published data or specifications exceed these standards, the manufacturer's standards shall be considered minimum and shall be furnished. All integral parts not specifically mentioned in the scope of these specifications that are necessary to provide a complete working unit shall be furnished. Additionally, the machine offered for bid shall include all standard manufacturers' equipment. The 16' Steel Dump Body must be a new current production model.

The use of specific names or numbers in the specifications is not intended to restrict the bidder or any seller or manufacturer but is intended solely for the purpose of indicating the type, size, and quality of equipment considered best adapted to the uses of counties participating in this joint bid.

BID SUBMITTAL FORM

Each bidder must submit his or her bid on the Bid Submittal Form included in the invitation to bid package. All written warranties to be submitted shall be attached to the Bid Submittal Form.

BID PRICE

The price bid shall include all destination charges, delivery charges, title fees, rebates and all other applicable costs and refunds.

REPLACEMENT PARTS AVAILABILITY

Parts must be available for 5 years or 500,000 miles of use for the piece of equipment bid.

ASSEMBLY AND DELIVERY

The dump body will be purchased for use with a heavy-duty dump truck chassis (with Automatic Transmission) bid separately. The dump body company will be responsible for assembly and installation of the dump body and related optional equipment, including the cost of the same. The selling truck chassis dealer will be responsible for delivery of the chassis to the dump body company, for installation. The Dump Body Company will be responsible for delivery of the complete dump truck unit to the Truck Chassis Company following installation, and assembly of the dump body and related options onto the truck chassis. **Freight to the dump body company will be included in the truck bidder's proposal. Dump body installation, assembly and Freight costs back to the Truck Vendor will be included in the dump body bidder's proposal.**

Truck Body Limited Warranty

Ox Bodies, Inc., a subsidiary of Truck Bodies and Equipment International (TBEI), warrants all new truck bodies and/or accessories purchased directly from Ox Bodies or from authorized re-sellers of Ox Bodies products for a period of 1 year from the date of sale to end the user/customer. This warranty must be activated with Ox Bodies within 30 days of sale to the end user/customer to be valid. This warranty is not transferrable once activated by the dealer or the end user/customer and warrants that our products shall be free of defects in material and workmanship under normal operating conditions and when properly maintained and operated as directed in the owner's manual for the duration of the warranty period.

This warranty is limited to truck bodies and/or accessories manufactured and/or installed by Ox Bodies; or installed by Ox Bodies authorized install sites. It does not cover post-production or distributor modifications made by other than Ox Bodies. These modifications include, but are not limited to:

- Installation of tarp (by other than Ox Bodies)
- Installation of vibrator (by other than Ox Bodies)
- Installation of bodies and stand alone components purchased from but not installed by Ox Bodies shall not be warranted.
- Any design modifications made by the end user/customer to the original Ox Bodies unit

Repair, replacement, or credit is at Ox Bodies discretion. Ox Bodies will not reimburse for work performed without prior authorization. Ox Bodies reserves the right to refuse estimates deemed excessive.

Environmental damage resulting from time spent on dealer lots is not covered by this warranty. This damage can include but is not limited to:

- Rust
- Storm damage
- Exposure to extreme temperatures
- Hoist failure as a result of being displayed for extended periods in the raised position

Paint warranty is limited to adhesion to metal surfaces only, and does not include either the inside or the understructure of truck bodies. Due to the nature of the product and its intended applications, truck bodies are painted white at the customer's own risk, and shall not be covered by this warranty.

Items such as loose bolts, loose or ungreased fittings, hydraulic leaks, electrical connections, loose lift axle mounting hardware, and unusual noises shall be warranted for a period of 90 days from date of sale to end user/customer. Issues of this nature reported after 90 days shall be considered the result of normal wear and subject to regular maintenance by the customer as detailed in the owner's manual and are not covered by Ox Bodies warranty. Failure to follow the maintenance regimen outlined in the owner's manual for the truck body and/or accessories will void the warranty. These items include but are not limited to:

- Grease fittings
- Tailgate pins
- Tailgate hinge bushings
- Hydraulic cylinder pins
- Rear hinge fittings
- Torque of bolts

This warranty is void if the unit has been abused, or has been subject to other than normal usage as explained in the owner's manual. No other obligation is assumed or authorized by Ox Bodies other than herein set forth.

Ox Bodies assumes no responsibility for fit, form, function, or failure of the chassis. Dealerships and distributors are responsible for the condition of the chassis prior to delivery to the customer. Damage occurring to the chassis before arriving at or leaving Ox Bodies premises shall not be warranted. Cosmetic damage resulting from transport will be covered only if the unit is hauled by Ox Bodies, and only if the damage is reported within 24 hours of delivery.

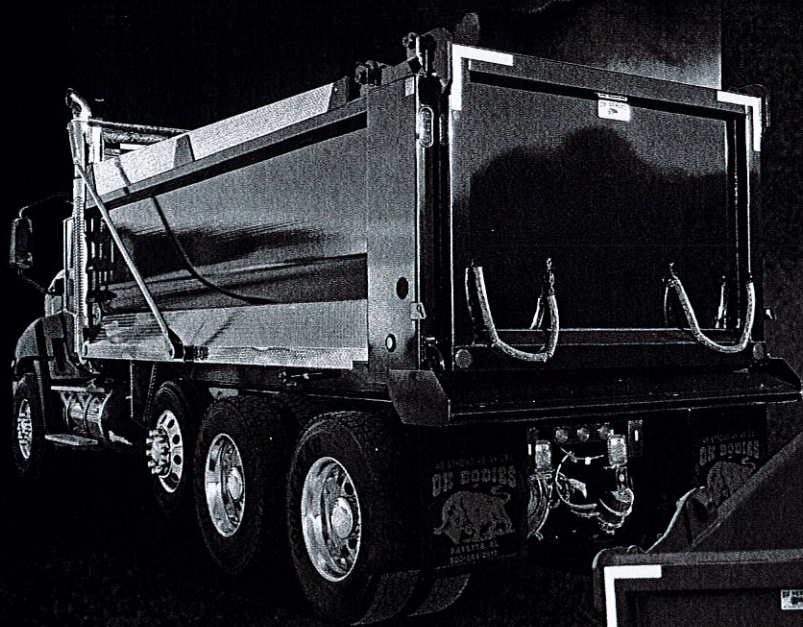

The specifics of each bid submitted will be compiled by the Association staff thereafter and will be available, upon written or emailed request, one week after the bid opening. THE INVITATION PACKAGE

The invitation package for each item to be bid includes: this invitation to bid, the written bid specifications for the particular item of heavy road equipment, and a Bid Submittal Form to be used in submitting a bid for that particular item. Bidders should verify that they have received all pages of the invitation package. If there are any omissions, the bidder should contact Kenya Howard in the Association office by mail, fax, or e-mail (jointbid@alabamacounties.org) to request missing pages. It is the responsibility of the bidder to make this request in sufficient time to prepare and submit the bid in time for the bid opening. Bidders should carefully read and comply with all parts of the invitation package, including all attachments and/or any addendum.

PREPARING AND SUBMITTING BIDS

All bids must be typed or handwritten in ink on the attached Bid Submittal Form. **The completed Bid Submittal Form shall be placed in front of and separated from all other documents included in the bid packet, such that it will be the first document viewed upon opening the bid packet.**
