INVITATION TO BID

The Covington County Commission is requesting sealed bids on the items specified and enclosed herein. Bids will be received in the County Commission Office, in the Administration Building, 260 Hillcrest Drive, P.O. Box 188, Andalusia, Alabama 36420 until 9:00 A.M., Thursday, April 09, 2026, and will be opened as soon thereafter as is practicable.

All bids must be sealed and clearly marked on the outside of the envelope, "**BID ON NEW PLASTIC PIPE, APRIL 09, 2026, 9:00 A.M.**" Any bid submitted by FAX transmission will not be considered valid.

It is understood that this bid will be a joint bid to be used by several counties. All stipulations and prices for all materials in this bid will be available and will apply to the following counties in the State of Alabama: Autauga County, Barbour County, Bullock County, Butler County, Chambers County, Coffee County, Covington County, Crenshaw County, Dale County, Elmore County, Escambia County, Geneva County, Henry County, Houston County, Lee County, Lowndes County, Montgomery County, Pike County, and Russell County.

(Note: All of the above listed counties reserve the right to purchase items meeting the same specifications for lower prices off the State of Alabama bid or the statewide county bid at any time during the prescribed contract period.)

If applicable, all materials bid must meet specifications of the latest edition of the Alabama Department of Transportation Standards and Specifications for Highway Construction. Failure to comply with this requirement may cause a bid to be rejected.

The contract shall cover the County's needs from April 26, 2026 through April 25, 2027 with an option to issue a second and third 12 month contract under the same pricing, terms, and conditions. The second and third contract, if requested by the county and agreed upon by the vendor, would begin the day after the first or second contract expires. Any successive contract must have written approval of both the County and the vendor prior to the expiration of the previous contract.

CORRUGATED POLYETHYLENE PLASTIC PIPE

Proposal to furnish high density corrugated polyethylene plastic pipe with an integral smooth interior wall to the nineteen (19) Counties in the State of Alabama listed on the Invitation to Bid, in sizes listed below. The pipe to meet AASHTO M294 type S Specifications. Joints meeting ASTM-F477 shall consist of a bell and spigot type with an o-ring rubber gasket placed on the spigot end. Pipe lengths shall be in 20, 24 and 30 foot sections.

The contract shall cover the County's needs for the period of April 26, 2026 through April 25, 2027 with an option to issue a second and third 12 month contract under the same pricing, terms and conditions. The second and third contract, if requested by the counties and agreed upon by the vendor, would begin the day after the first or second contract expires. Any successive contract must have written approval of both the awarding County and the vendor no later than 30 days prior to the expiration of the previous contract.
