**Pike County** is taking sealed bids for labor, equipment, materials, and any incidentals required to complete the work required for road improvements above on **approximately 5.0 miles Pike County roads known as Project No. PCP 55-02-26, ETC.** This bid is intended to comply with the Rebuild Alabama Act, No. 2019-2, and Alabama Code Title 39, of the Alabama Public Works Law. Bidders shall be required to comply with the provisions of the Rebuild Alabama Act, No. 2019-2 and Title 39 of the Alabama Code regardless if the requirement is explicitly detailed in the bid proposal or not.

Only bids from contractors or material suppliers listed on the Alabama Department of Transportation (ALDOT) approved list of contractors and material suppliers will be accepted.

The contractor shall meet all Alabama Department of Transportation (ALDOT) Bonding and License requirements as well as applicable laws, ordinances, and codes of the U.S. Government, the State of Alabama, and relevant municipality, and the COUNTY, and, specifically and without limitation, shall comply with all provisions of the Beason-Hammond Alabama Taxpayer and Citizen Protection Act, commonly referred to as the Immigration Act.

Sealed bids will be received by the Pike County Commission at the **Pike County Road Department, 301 Riverview Drive, Troy, AL 36079** until **11:00 AM, Wednesday, July 8, 2026** and then publicly opened as soon thereafter as practicable. Award will be made at a later date at a regularly scheduled meeting of the Pike County Commission.
